I state that I have read and understood the contents of this affidavit and the same has been drafted under my instructions and after carefully going through the same, I state that the statements and submissions made in this affidavit are true and correct to the best of my knowledge and belief, are based on information and I believe them to be true and it is stated that no part of it is false and nothing material has been concealed there from.
- 4. Tata Power-D has filed a Tariff petition for FY 2024-25 on 17th January, 2024 as Case No 237 of 2023. The same has been admitted by the Hon'ble Commission on 19th January, 2024. Tata Power-D in the petition has proposed the Cross Subsidy considering Cross subsidy of parallel distribution licensee adjusted for a) Cross subsidy proposed in such a manner that it should be within +/- 20% and b) the total revenue requirement is met with change in existing tariff. Some discrepancies in proposed tariff have been pointed out by Tata power-D consumer today after publication of Notice in Newspapers. On checking it was found that inadvertently the energy charges proposed were based on erroneous formula which are not in line with the above tariff philosophy. In view of this Tata Power-D wish to submit this additional submission incorporating the corrections in relevant tables of the petition to address the suggestions/ objections received from the consumer. This does not change any of the ARR numbers or proposals which remain intact.
