The voting period for remote e-voting commenced on Sunday, August 27, 2023 at 09:00 a.m. (IST) and ended on Monday, September 25, 2023 at 05:00 p.m. (IST) and the NSDL e-voting module was disabled thereafter.

The votes cast under remote e-voting facility were thereafter unblocked.
