### 1. INTRODUCTION:

Tata Power Company limited is hereby inviting Expression of Interest (EOI) from interested and eligible parties for " **Supply and supervision of erection, testing and commissioning of Butterfly Valves for sea water application**" for Mundar Thermal Power Station, 4000 MW (800 x 5 units) UMPP near the port city of Mundra in the state of Gujarat in India

### 2. SCOPE OF WORK:

The Scope of Work under this tender includes design, manufacture, inspection, testing at Bidder's and/or his Sub-Vendor's works, packing, transportation from place of manufacture to site, unloading at site and assistance at site if found necessary by Bidder for proper installation & commissioning of large size butterfly valves, NRVs and associated accessories, as specified etc.

Detailed Scope of Work for this Contract shall be provided in the Tender / RFQ document to all potential buyers submitting the valid EOI with due tender fees.

### 3. TENDER FEE & TIMELINES:

3.1. Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for Bid Document / EOI will not be entertained beyond this deadline.

3.4. **Expression of Interest letter to be submitted along with tender fee payment details should include the following details:**

- A covering letter duly stamped and signed by an authorized signatory clearly indicating the Tender Reference number and your EOI to participate in the tendering process.
- Tender fee payment details / reference no (ensure that tender fee is received by us within specified deadline)
- Bidder to indicate authorized person name, contact number and e-mail id (mandatory) of the person to whom RFQ / tender and all other communications to be addressed for this tender.

3.5. Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

#### 4. BIDDER PRE-QUALIFICATION REQUIREMENTS:

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification requirement / criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.

##### 4.1 TECHNICAL REQUIREMENT:

- 4.1.1 The Bidder must have proven experience and shall have supplied Large size butterfly valves and NRVs 800NB or higher size for at least two (2) no. of projects wherein minimum quantity of valves of 800NB and above should be 12 nos. per project, in past 5 years.
- 4.1.2 Bidder should have experience of supply of valves in sea water application and metallurgies of duplex stainless steel, CF8M, etc
- 4.1.3 Bidder shall submit the following document along with the Bid Document in support of the qualification criteria specified above:
  - a. Reference list of similar projects executed in past 5 years mentioning the brief project description and type & size of valves supplied.
  - b. Work completion / commissioning certificates for successfully executed projects for minimum 2 projects of similar nature of job.

##### 4.2 FINANCIAL REQUIREMENT:

Bidder shall have an Average Annual Turn Over of not less than INR 20 Crores during the last three financial years.

#### 5. BID SECURITY / EMD:

Interested parties to note that Bidder will be required to furnish a Bid Security **along with their Bid**, in the format prescribed in Bid Document **in the form of Bank Guarantee/ DD/ RTGS**, for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

**Interested parties to note that Bid Security is not required with the EOI and it is required to be submitted with the Bid only during Bid Submission stage**, once RFQ is released to the interested parties that have submitted a valid EOI.

#### 6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties that submitted a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
