## 1. INTRODUCTION:

## 2. SCOPE OF WORK:

- ✓ Scope of work area includes PPGCL plant, township, Hospital, School, Intake area, Material Gate, 50KT Silo, Ash Dyke area and nearby localities.
- ✓ All fire personnel should be qualified, certified and trained in basic firefighting course from state fire training institute or equivalent institute approved/recognised by State Fire Services.
- ✓ All fire persons should be well conversant with all fire equipment's, appliances, fire detection and protection systems.
- ✓ All fire persons should be capable of read/write Hindi and English language and capable of writing logbook/occurrence book in Hindi/English languages.
- ✓ Attending and effective mitigation of all emergency calls such as fire, rescue, animal rescue, chemical leakages, gas leakages, natural calamities, etc.
- ✓ Ensure 24x7 manning of fire department which should comprise of Site Manager cum Fire Safety officer, Shift Incharge / Supervisors, Driver/Pump Operators, Control Room Operators, firemen and leave reserve.

Detailed Scope of Work for this Contract shall be provided in the Tender / RFQ document to all potential buyers submitting the valid EOI with due tender fees.

### 3. TENDER FEE & TIMELINES:

- a) Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee (as indicated in Table 1) payment details to the contact details mentioned below not later than deadline specified below. Request for extension of EOI submission date will not be entertained and EOIs submitted beyond this deadline may be liable for rejection.

### 4. BIDDER PRE-QUALIFICATION REQUIREMENTS:

Bidder must fulfill the following bidder pre-qualification requirement / criteria to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.

#### 4.1 TECHNICAL REQUIREMENT:

- The bidder should have a minimum of 05 years' experience for Fire Service for PPGCL Plant and Associates Areas under the engaging of minimum 30 nos. of manpower in Large Scale Industries such as Refineries, Petrochemical, Chemical, Fertilizer, Power, Steel Industry
- The bidder must have executed at least two to three (2-3) orders each of Single value is Rs. 1 Crore/year for similar type of work in the last Four - Five years.
- The bidder must have minimum one running contracts for the Annually Round of Clock for Fireman Service.

#### 4.2 FINANCIAL REQUIREMENT:

Company's financial performance documents, i.e. Audited Balance Sheets, Profit and Loss Account, and Cash Flow Statements for the last three years and following details required separately. Provisional, authenticated balance sheets are also acceptable; however, failure to provide three audit statements will lead to rejection of bid:

- Company Average turnover based on last three audited financial statements which should not be less than 2.54 Crore (Two Crore Fifty-four lakhs) in form of Indian Rupees.
- Company's net worth based on last three audited financial statements during the last three financial years. FY 21-22, FY 22-23, FY23-24 (Attach the certificate from Chartered Accountant in this regard).

- c) Working capital based on last three audited financial statements.

It may be noted that the above requirements are minimum qualification criteria. However, PPGCL reserves its right to further assess the capabilities of the parties and reserves its rights to further shortlist, accept or reject any party without assigning any reason.

**4.3 Notes for financial requirements.**

- Bidder should be an independent company, a proprietorship firm, a partnership firm or a combination of above in form of Joint venture Company, registered as per Companies Act. Bidder to share relevant details of the bidding entity.
- Bidder should share Certified copy of Income TAX, PAN, GST/ Other Taxes Duties Certificate and EPF registration (or undertaking in case not applicable) issued by competent authority.

**4.4 SUPPORTING DOCUMENTS (to be submitted with Technical Bid):**

- a) PO Copy, Completion Certificate from the concerned client in support of successful execution of jobs /reference projects to be submitted.
- b) Experience details of past 05 years should be submitted in RFQ.
- c) Audited Balance Sheet and Profit & Loss Statement for last the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered Accountant may be submitted.

**5. BID SECURITY / EMD (to be submitted along with RFQ and not with EOI)**

Interested parties to note that Bidder will be required to furnish a Bid Security along with their Bid, in the format prescribed in Bid Document in the form of RTGS for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Interested parties to note that Bid Security is not required with the EOI, and it is required to be submitted with the Bid only during Bid Submission stage once RFQ is released to the interested parties that have submitted a valid EOI.

**6. BIDDING PROCESS:**

Detailed Bid Document (also referred as RFQ) shall be issued through PPGCL e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
