1. INTRODUCTION:

Tata Power Jojobera Power Plant (547.5 MW) Source coal from various CIL Subsidiaries (~17-18LMT/Annum) & from Tata Steel West Bokaro mines (~14 LMT/Annum) for power generation and approximately 10-12 LMT of ash is being generated annually. In order to promote utilization of Fly Ash as resource material on long term basis, Tata Power Company limited is hereby inviting Expression of Interest (EOI) from interested and eligible parties (Traders) for Sale of FLY Ash (**1LMT/Annum**) from Jojobera Power Plant. through Rail / ROAD Mode.

- 1) Collection and Transportation of Conditioned Fly Ash from Silo to designated Railways siding inside the Jojobera Power Plant
- 2) Stacking at Railway siding
- 3) Rake arrangement & all associated activities for rake arrangement
- 4) Loading into rakes & covering with Tarpaulin

Road Mode

- 1) Arrangement of Bulkers
- 2) Loading from Silo
- 3) Helper must be available with Bulker
- 4) All RTO, Environmental permission shall be in scope of vendor

3. TENDER FEE & TIMELINES:

a) Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for Bid Document/EOI will not be entertained beyond this deadline.

b) Expression of Interest letter to be submitted along with tender fee payment details should include the following details:

- A covering letter duly stamped and signed by an authorized signatory clearly indicating the Tender Reference, your Expression of Interest to participate in the tendering process.
- Authorized person name, contact number and e-mail id (mandatory) of the person to whom RFQ/ tender and all other communications to be addressed for this tender.
- Tender fee payment details / reference no (ensuring that tender fee is received by us within specified deadline)
- Attach the supporting documents substantiating your fulfillment of Bidder's Pre-Qualification Requirements (PQR), with the EOI. In case of supporting documents are not readily available, bidder to provide confirmation that they shall arrange to share PQR supporting documents later on as required by owner.

e) Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

4. BIDDER PRE-QUALIFICATION REQUIREMENTS (PQR):

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification requirement/ criteria in order to qualify for the subject work tender. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ and bidders not found meeting the pre -qualification requirements given below will be disqualified from the tender.

4.1 TECHNICAL REQUIREMENTS:

- a) Bidders should themselves be an end user agency of fly ash/ Pond Ash as per MOE&F Notification and have MPCB approved ash utilization facility or have tie ups with such end users like Cement Industries, Trading Companies or Construction Companies. Undertaking will have to be submitted in this regard by Bidder/Buyer. Bidder shall submit the consent to operate for the proposed fly ash utilization facility (PO copy along with credential copy to be attached)
- b) Bidder meeting criteria should substantiate experience of handling at least 1.0 LMT ash quantity during last two years via rail / Road mode

Note

1. Tata Power reserve the right to disqualify any of bidder based on due diligence
2. The existing lifters via bulker shall be deemed qualified only for this tendering process

4.2 FINANCIAL REQUIREMENTS:

- a) Bidder shall have during the last three financial years an Average Annual Turn Over of not less than INR 50 lakhs

- b) Bidder should share copies of their profit and loss account and audited Balance sheet for the last three preceding financial years along with the Bid Document. In cases, where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.

Notes for Financial Requirements

1. Net Worth means the sum total of the paid-up share capital and free reserves for private / public limited companies and the Surplus Capital employed by owners in a proprietorship / partnership companies. Free reserves mean all reserves credited out of the profits and share premium account but do not include reserves credited out of the revaluation of assets, write back of depreciation provisions and amalgamation. Further, any debit balance of profit and loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from Reserves & Surplus. Other income shall not be considered for arriving at annual turnover.

5. BID SECURITY/EMD AT STAGE OF RFQ/BIDDING:

Interested parties to note that Bid Security is not required with the EOI and Bid Security will be required to be submitted only along with the Bid process (to happen subsequent to EOI and issue of Bid Document to valid EOI participants), via online transfer only for an amount of INR 10,00,000/- (Indian Rupees Ten Lakhs Only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive.

Interested parties to note that EMD/Bid Security is not required with the EOI and it is required to be submitted with the Bid during RFQ/Bidding stage, once RFQ is released to the interested parties submitting valid Expression of Interest.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (SAP Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this Tender Notice.

Bidder to note that bidding for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed during RFQ/Bidding Stage.
