1. INTRODUCTION:

Prayagraj Power Generation Company Limited (PPGCL) owns and operates 3x660 MW capacity Indian coal based thermal power generation station based on pulverized coal-based super-critical boiler technology. The generating plant is in Tehsil Bara, Dist-Prayagraj in the state of Uttar Pradesh in India. A brief overview of Owner and Site is given below:

Site Location	PPGCL site is located in Bara Tehsil in Prayagraj District, Uttar Pradesh. Site is at distance of about 34 KM from Prayagraj town in the district of Prayagraj. Latitude and Longitude of site is 25.200 N and 81.660 E respectively. The site is well connected by rail (nearest railway station is Lohgara on the Mumbai-Allahabad route) and road (located on NH35).

Access to Site	Plant is located on National Highway NH 35. Bamrauli Airport, Prayagraj is the nearest airport which is about 55 KM from Site.

PPGCL intends to maintain and award the contract for Repair & Revamping of 3 blocks at labour camp. The objective of this EOI is to invite competent vendors having the relevant experience in the above work of " Repair & Revamping of 3 blocks at labour camp in PPGCL plant."

2. SCOPE OF WORK:

Renovation of roof, Brick Wall, painting, puff roof sheeting work and misc. fabrication work etc.

Detailed Scope of Work for and Terms & conditions for this Tender/ Contract shall be provided in the Tender/RFQ document to all bidders submitting the valid EOI with due tender fees.

3. TENDER FEE & EOI SUBMISSION GUIDELINES AND TIMELINES:

a) Interested parties meeting the "Bidder pre-qualification criteria" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for Bid Document / EOI will not be entertained beyond this deadline.

b) Tender Fee, as indicated in the Table1 above may be paid through **NEFT** as per details for

payment of Tender Fee given in Table3 below:

c) Interested bidders should submit the Expression of Interest (EOI) letter and tender fee payment details to below mentioned email addresses:

EOI/ requests without complete information and communication as above within deadline shall be liable to be rejected and will not be considered further.

d) Expression of Interest letter to be submitted along with tender fee payment details should include the following details (To be mentioned in editable format in email body):

- Company Name and Office Address
- Authorized Contact person name, contact number and e-mail id (mandatory) for bidding purpose and for all other communications to be addressed for this tender.
- Tender fee payment details / reference no (ensuring that tender fee is received by us within specified deadline)
- Attach the supporting documents substantiating your fulfilment of Bidder's Pre-Qualification Requirements (PQR), with the EOI. In case supporting documents are not readily available, bidder to provide confirmation that they shall arrange to share PQR supporting documents later on as required by owner.

e) Detailed Bid Document (also referred as RFQ) shall be issued through PPGCL e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

4. BIDDER PRE-QUALIFICATION CRITERIA:

Interested parties to note that Bidder shall be required to fulfil the following bidder pre-qualification criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ.

4.1 TECHNICAL REQUIREMENTS:

- a) Bidders have experience of operational Plant premises for General civil and fabrication puff roof sheeting work in past for 4-5 years and submit the completion certificate/ single PO copy 2-3 of equivalent to project value.
- b) Deployed experience site team with minimum 5-6 years' experience in painting work.
- c) Bidder must deploy the quality site engineer (QA/QC) Staff.
- d) Bidder must follow the safety standard as per the PPGCL norms, safety standard shall be shared in RFQ.
- e) Qualified safety officer to be deployed at site with a minimum of 5–6 years' experience.
- f) Competent team of scaffolding work to be deployed at site.
- g) No sub-letting and sub-contracting of PPGCL assigned PO work in any form is allowed.
- h) Quality of work and quantities shall be notified to the Employer whose technical personnel or consultant will certify the work. Any defect or shortcoming in the work shall be made good by the contractor to the full satisfaction of the Employer.
- i) The contractor shall make all provisions for safety of his men and materials including insurance for fire and accidents. An indemnity bond in the form appended shall be submitted indicating clearly that the Employers are free from such responsibility and encumbrances.
- j) The Contractor shall normally have to make his own arrangement for storing/deploying the materials, manpower, tools tackles etc. required for the works.
- k) PPGCL reserves the right to increase or decrease the scope of the Work on any or all items or to change the nature of the Work involved in any or all items or to completely delete any

items of the Work under the Contract. The Contractor shall not be entitled to claim for loss of anticipated profits, for mobilization of additional resources, or for any other such reason on account of these changed "Repair & Revamping of 3 blocks at labour camp" at PPGCL. The Contractor is bound to carry out any items of work necessary for the completion of the Work even though such items of work may not be expressly described in the Contract Documents.

- l) All statutory registration (EPF/ESIC/GST/PAN) along with other statutory registration/requirements required by statutory authorities for carrying out housekeeping services and other allied works.

4.2 FINANCIAL REQUIREMENTS:

Company's financial performance documents, i.e. Audited Balance Sheets, Profit and Loss Account, and Cash Flow Statements for the last three years and following details required separately. Provisional, authenticated balance sheets are also acceptable; however, failure to provide three audit statements will lead to rejection of bid.

- ✓ Company Average turnover based on last three audited financial statements which should not be less than **1 Crore (One Crore)** in form of Indian Rupees.
- ✓ Company's net worth based on last three audited financial statements during the last three financial years. **FY 20-21, FY 21-22, FY22-23** (Attach the certificate from Chartered Accountant in this regards).
- ✓ Working capital based on last three audited financial statements.

It may be noted that the above requirements are minimum qualification criteria. However, PPGCL reserves its right to further assess the capabilities of the parties and reserves its rights to further shortlist, accept or reject any party without assigning any reason.

Notes for financial requirements:

- a) Bidder should be an independent company, a proprietorship firm, a partnership firm or a combination of above in form of Joint venture Company, registered as per Companies Act. Bidder to share relevant details of the bidding entity.
- b) Bidder should share Certified copy of Income TAX, PAN, GST/ Other Taxes Duties Certificate and EPF registration (or undertaking in case not applicable) issued by competent authority.

4.3 SAFETY REQUIREMENT:

- a) The bidder should preferably have ISO 9001 / ISO 14001 / ISO 45001 certification or must give an undertaking for its willingness to obtain the same within 2 months of qualification for the work.
- b) Bidder should be competent for high-risk job and work at height as per PPGCL/Tata power safety standards.
- c) A Site Safety Plan shall be prepared by a successful bidder along with order manager
- d) Tata Power Safety procedures issued with General Conditions of Contract and safety rules & guidelines being issued time to time must be followed by the successful bidder
- e) Safety Officer deployed for this job - mentioned in submitted documents should have relevant experience & in case of any change it should be done after approval of PPGCL management.
- f) All the employees exposed to actual job should be certified in "L1 Foundation Course in Safety" and 'L2 course in Electrical safety, working at height & any other course as per requirement which will be conducted by TPSDI before start of job.
- g) Supervisor must be certified in L1/L3 from TPSDI.
- h) Any other training suggested by Order Manager and Site Safety Head..
- i) During the activity, Safety Officer/Competent Supervisor to be deployed.
- j) Tools & Tackles used to carry out the job shall be checked by Order Manager for healthiness & proper working.
- k) Working at height procedure to be followed. Full body harness (Safety belt) with double

- lanyard to be used while working on height.
- l) All Electrical Hand Tools must be tested for leakage of current and power must be taken from RCCB of 30mA. Electrical hand tools should not have supply wire more than 3 meters in length. If power source is available at a distance of more than 3 meters, extension boards with RCCB and ON/OFF switch shall be used.
 - m) Standard Job specific tools & Tackles to be used. To be ensured calibration of tool where applicable.
 - n) SOP to be prepared by PPGCL concerned department under whom job is assigned & to be followed.
 - o) No Sub-contracting of jobs without safety assessment of the sub-contractor. Penalty as per CSCC will be applicable to the contractor if he appoints subcontractor without the permission of engineer in-charge and without evaluation through CSCC process.
 - p) No Supervision No work policy should strictly be followed.

Permit to work - LOTO procedure shall be used at all times. HIRA /JSA as per the job scope must be prepared in detail and submitted along with Site Safety Plan by the successful bidder. Daily Toolbox talk along with job specific JSA (Job Safety Analysis) to be discussed by supervisor & site safety officer. Applicable critical safety work procedures like Work at height, Excavation, Electrical Safety, LOTO, PTW etc. as per PPGCL guidelines Personal protective equipment (PPE) must always be checked before use to ensure that it is in good condition and clean. Replace them if necessary. And should be as per standards. All relevant PPE shall be provided by the vendor while working at the site.

- a) Before carrying out work, permission with proper PPGCL procedures to be taken from the concerned PPGCL Officer.
 - b) All Professional Divers/technicians with competency certificate to be provided.
 - c) As per Job- Deployment tools to be certified through third or manufacturing certificates.
 - d) Standard & quality PPE's to be used.
 - e) Ensure First Aid awareness is imparted to all employees.
 - f) Ensure Site Emergency plan is available & awareness to be ensured to all employees. Site Evacuation plan should be available & displayed at strategic location.

5. BID SECURITY:

Interested parties to note that Bidder will be required to furnish a Bid Security(EMD) along with their Bid, in the format prescribed in Bid Document in the form of RTGS for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Interested parties to note that Bid Security is not required with the EOI, and it is required to be submitted with the Bid only during Bid Submission stage once RFQ is released to the interested parties that have submitted a valid EOI.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through PPGCL e-tender portal(Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
