1. INTRODUCTION:

Prayagraj Power Generation Company Limited (PPGCL) owns and operates 3x660 MW capacity Indian coal based thermal power generation station based on pulverized coal-based super-critical boiler technology. Procurement of BELT -EP 1600/5.

Detailed technical specification and rest all terms & conditions for this Tender/ Contract shall be provided in the Tender/RFQ document to all bidders submitting the valid EOI with due tender fees.

Request for Bid Document / EOI will not be entertained beyond this deadline.

In case supporting documents are not readily available, the bidder provides confirmation that they shall arrange to share PQR supporting documents later as required by the owner.

4. BIDDER PRE-QUALIFICATION CRITERIA:

Interested parties note that bidder shall be required to fulfil the following bidder prequalification criteria to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ.

 - II. Nos of Ply: 5
 - III. Top Cover Thickness: **5 mm**
 - IV. Bottom Cover Thickness: **3 mm**
 - V. Nominal Thickness of Carcass: 8.5 mm
 - VI. Weight of Carcass: 9.4 Kg/M
 - VII. Calculated Weight of Belt per Meter length including Cover: 35.05 Kg
 - VIII. Belt Covers: FR CAN CSA M422 M87 TYPE'C'
 - IX. Cover Rubber Hardness: 65 ± 5 mm

- X. Maximum Recommended Belt Tension: 180 KN/M
- XI. Maximum Recommended Belt Tension for Full width: 324 KN
- XII. Belt Edge Construction: Moulded Edge
- XIII. Carcass Skim Coated: Yes
- XIV. Troughing Angle of Conveyor: **35 Degree**
- XV. Belt is pre stretched: Yes.
- XVI. Belt Duty: Heavy Duty
- XVII. Nylon Breaker: Nylon Breaker on top

- XXXI. Fabric Width should be in **One/Single** Piece
- XXXII. Maximum Nos of Patch Repair in Belt: Limited to 03/100 Mtr
- XXXIII. Maximum Nos of Patch Repair & Buffing/Dough filling in Belt: Limited to 05/100 Mtr
- XXXIV. Maximum Patch Repair Size area of each repair shall be limited to 1/5 w x 1/5 w, where w is width of the belt.

Technical criteria:

- a) The vendor shall have experience to 7 to 10 years' experience in supply of Belt Conveyor Supply of BELT -EP 1600/5, FR GRADE WITH BREAKER PLY 1800MM WIDTH, TOP-5MM, BOTTOM-3MM.
- b) The bidder must share a minimum of 3 different last purchase orders against Belt Conveyor Supply.

Notes for financial requirements:

- a) Bidder should be an independent company, a proprietorship firm, a partnership firm or a combination of above in form of Joint venture Company, registered as per Companies Act. Bidder to share relevant details of the bidding entity.
- b) Bidder should share Certified copy of Income TAX, PAN, GST/ Other Taxes Duties Certificate and EPF registration (or undertaking in case not applicable) issued by competent authority.

5. BID SECURITY:

Interested parties to note that Bidder will be required to furnish a Bid Security along with their Bid, in the format prescribed in Bid Document **in the form of through RTGS**, for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Interested parties to note that Bid Security is not required with the EOI, and it is required to be submitted with the Bid only during Bid Submission stage once RFQ is released to the interested parties that have submitted a valid EOI.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through PPGCL e-tender portal(Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
