

### CM: Cabinet sub-committee to be set up to address issues of OBC

AMID FEARS among the Other Backward Classes (OBC) that their existing quota will be reduced to accommodate reservation for the Marathas in jobs and education, Chief Minister Uddhav Thackeray on Friday said that a Cabinet sub-committee will be set up to address the issues faced by OBC communities. He also assured that reservation of OBC communities would not be reduced.

In a meeting with OBC and Dhangar community leaders on Friday, Uddhav said: "We are aware of the demands and issues faced by the OBC communities. A Cabinet sub-committee will be set up immediately to address them expeditiously. This committee should consider the demands of the communities and speed up the decision-making process."

"The Cabinet sub-committee should decide on priority work first while requesting funds from the government," he added.

The meeting was attended by NCP leader and Minister for Civil Supplies Chhagan Bhujbal, Congress leader and Minister for Relief and Rehabilitation Vijay Wadettiwar and former MLA Prakash Shendage among others.

### ATS gets new chief, Bharti in charge of MSSC

JAJJEET SINGH, a 1990-batch IPS officer, was on Friday named the state Anti Terrorism Squad (ATS) chief, replacing Deven Bharti who was given the charge of Maharashtra State Security Corporation (MSSC).

While Bharti was transferred on September 2, he was not relieved by the state police in the absence of a replacement.

Besides, the state government appointed Niket Kaushik as the joint commissioner of police (Economic Offences Wing) and Rajwardhan, whom he replaced, as the special IG (Prevention of Atrocities against Women). Kaushik, who was earlier the IG (Konkan range), has been replaced by Sanjay Mohite.

Naval Bajaj, who was earlier the joint commissioner of police (Administration), has been made the additional director general (Economic Offences Wing) on promotion. He replaced Prabhat Kumar, who has been transferred as ADG (Anti Corruption Bureau).

### 7 cops booked for 'parading juveniles on the street' in Nagpur

SEVEN POLICEMEN from Nagpur city's Jaripatka police station were booked on Friday for allegedly parading five juveniles semi-naked on the street and beating them along the way.

The five juveniles had been detained in connection with an armed robbery in a liquor bar.

A video of the incident, which took place on September 23, had gone viral. In the video, the policemen can be seen beating the juveniles even as the latter begged for mercy.

An inquiry was conducted into the incident by Assistant Commissioner of Police Parshuram Karyakartta. "We have booked seven policemen for parading the five juveniles... semi-naked on the street and also for assaulting them," said Police Commissioner Amitesh Kumar.

He added, "We have booked them under Sections 74 and 75 of the Juvenile Justice (Care and Protection) Act."

The policemen booked in the case are Senior Police Inspector Khushal Tijare, Sub-Inspector Vijay Dhimal and Police Constables Laxman Chaware, Mahesh Yadav, Rohan Tiwari, Daga and Sunil Mahajan.

# BJP legislators to visit farmers across state to explain new laws

STARTING FRIDAY, BJP MPs and MLAs will visit farmers in villages across the state over the next two weeks to explain to them the new farm laws passed recently by the Parliament. The campaign will be spread across Vidarbha, Marathwada, north and western Maharashtra as well as Konkan region.

The BJP's farmers' outreach comes after the Uddhav Thackeray-led government, in the wake of largescale protests by farmer outfits across India, said the laws won't be enforced without consultations.

Not only will the state BJP hold personal interactions with farmers, it also plans to dig deeper into the three ruling allies adopting varied stances during the debate on farm Bills in the Parliament.

Leader of Opposition in the state Assembly, Devendra Fadnis, has urged the party to study NCP president Sharad Pawar's take on the farm laws.

"Pawar's day-long fast (over the farm Bills) was a protest against the suspension of members from the Rajya Sabha (over their protest regarding the passage of the Bills). It was not for the passage of Bills," Fadnis told *The Indian Express* while recalling that the NCP chief's earlier interviews and biography where he had expressed the need for an open and competitive market to ensure farmers get higher remuneration.

"The BJP plans to show the divide within the government. While Congress is opposing the reforms, NCP and Shiv Sena are in favour of the theory behind the campaign," said a party leader.

"The pamphlets prepared by us also highlights that the Congress, in its election manifesto,

had supported agricultural reforms. The 2006 reforms, including contract farming, was passed when Congress and NCP were in power," the leader added.

The campaign attempts to convey to the farmers that the new laws would empower them, said party leaders. "BJP believes there is clear a divide among farmer unions. Not everybody is against these laws. Thus, the protest in the state was mild when compared to others," a leader said.

Former agriculture minister and BJP Kisan Cell president Anil Bonde said, "The strength of the laws lie in the assurance that rights of farmers are non-negotiable. Irrespective of a contract signed between farmer and companies or loss of profit, agriculture land remains with individual farmer. The laws also have a clause that even after losses, companies have to pay for the produce procured from farmers."

## 188 patients, staffers test Covid positive at four mental hospitals

VULNERABILITY TO Covid-19 among patients and staff at government-run mental institutions has come to the fore with the state health department recording a total of 188 cases at four such hospitals in Pune, Thane, Nagpur and Ratnagiri as of October 7. Out of them, 68 are patients and 120 are staff members.

According to state health data till October 7, the highest number of Covid-19 cases are at the government mental hospital in Thane, where all 782 patients underwent tests and 42 tested positive for the novel coronavirus. Among staff too, all 436 people were tested and 40 came out to be positive.

At Ratnagiri government mental hospital, from among 109 patients, 46 with symptoms were tested and 10 were found to be positive. Out of 82 staffers, 50 with symptoms were tested and 14 were positive.

In Nagpur, out of 412 patients, 225 were tested and 10 were found to be Covid positive, while 26 tested positive out of 190

staffers with symptoms. The total number of staff at this hospital is 216. At the regional mental hospital in Pune that has the largest number of patients at 1,019, 305 with symptoms underwent testing of which six were found to be Covid positive. At the hospital, out of 646 staffers, 133 with symptoms were tested and 40 were found to be positive.

Dr Duryodhan Chavan, assistant director of health, mental health programme, told *The Indian Express* that patients had been quarantined at isolation wards in the mental hospitals and were constantly being monitored.

According to guidelines by Indian Council of Medical Research (ICMR), only those who were symptomatic underwent testing, said Dr Abhijeet Phadnis, Superintendent of Regional Mental Hospital at Pune.

"We have referred them to Sassoon General Hospital and after the 10-day isolation period, they are under quarantine inside their separate rooms at the mental hospital; we have ensured that they can see others by maintaining distance and using necessary protective gear. Some of our social workers also counsel them," Dr Phadnis said.

### 75% posts filled

Officials from the state mental health cell said they had strengthened the mental health programme across 34 districts and 70 per cent out of 260 posts had been filled.

A team of at least six to seven persons, including psychiatrist, clinical psychologist, nurse, record-keeper, and others, had been identified under the district mental health programme (DMHP). "We have issued advertisements and at least 75 per cent of 260 posts have been filled," Dr Chavan said.

He added that they had held meetings with psychiatric associations, whose members were involved in counselling patients during lockdown.

From April 3 to August 12, DMHP teams visited 1,933 migrant shelters across the state and counselled 1.2 lakh migrant workers. The teams visited 394 isolation wards at Covid Care Centres and other facilities and counselled 30,300 Covid patients. At 135 dedicated Covid hospitals, 29,928 patients were counselled, he said.

# How proctoring keeps a tab on candidates taking online exams

WITH COLLEGES allowing students to take final-year exams online from home, proctoring, a technology deployed to ensure the identity of the test taker and the integrity of the test taking environment has gained currency.

### What is proctoring, and why is it necessary?

At exams conducted in colleges, invigilation helps keep a check on students. For online exams taken at home, the possibility of cheating increases. Several universities have adopted a multiple choice questionnaire format, which might also enable a candidate to quickly search the Internet for the right answers. To maintain the veracity of an individual's grades, as a measure to evaluate a student's performance, invigilation becomes mandatory. Proctoring comprises artificial intelligence (AI) based algorithms and tools that keep a check on candidates during online exams not taken at an exam centre.

### What set of rules does a candidate need to comply with during online exams?

Most commonly, college or government-issued identity cards are to be displayed by candidates in front of the camera to prove their identity at the time of taking the examination. Use

of electronic devices, textual material and stationery items like smart watches and pen drives is prohibited, and so is the use of telecommunication devices like cellphones, head phones, bluetooth earphones, pagers and health bands among others. A candidate has to make sure that there is no noise in the background during the exam. No other application or web page should be open on the computer except the provided exam software.

Switching, minimising or closing the exam window is not allowed. A candidate also has to ensure the availability of hardware, software, broadband Internet and power backup. Further, no other person should be present in the room.

### How does proctoring work?

Before the exam begins, the image of the student on the screen is compared with the photo available in the system, based on which a user is allowed to continue.

AI-based algorithms keep users from opening other tabs on their screen. In case of multiple such attempts, the examinee is suspended from appearing for exam in most cases. The algorithms also keep a record of the number of times students opened other windows, and captures surrounding audio. Any change in the user's line of sight

— to the left or right — is flagged to the invigilator by an alert. Audio-video streaming or continuous capturing of photos at intervals of about 15 to 20 seconds, which can amount to 200 to 240 images in an hour, is deployed, apart from capturing all activity on the user's screen.

### What are the types of proctoring?

Proctoring can be done in two ways: full-view and face proctoring. In full-view proctoring, the student's laptop is kept on the side at a suitable vantage point to obtain a view of his or her face, hands, answerbook, and the cellphone used to take the exam. The "full view" can also be obtained using a phone instead of a laptop, but has limitations such as storage issues.

In face-view proctoring, a student takes the exam on a laptop, and the laptop camera monitors his or her face. The hands are not visible. Given the limitations of equipment and Internet connectivity faced by students, most institutions have opted for this mode of remote proctoring. However, there are two types of integrity risks with face view proctoring — there are

### Is this method full-proof?

Regardless of the technology solutions adopted by colleges, there is a common consensus among faculties that online exams are not full-proof. "The software deployed for exams has so far not flagged any student for misconduct, yet we have come across screenshots of question papers that are being shared on informal WhatsApp groups. Most students have been achieving good marks, which would not have been the case if physical exams were to be conducted," said an exam coordinator of a south Mumbai college.

Videos have been trending on YouTube explaining ways to cheat during online exams. Institutions such as IIT-Bombay have proposed solutions requiring a laptop with a webcam and a smartphone, or two smartphones in the absence of a laptop, to minimise instances of cheating. However, it may still not be a full-proof solution to curb malpractices.
