#### 1. INTRODUCTION:

The Tata Power Company Limited (TPC) is among the largest private sector Power Utility companies in India with presence in Generation, Transmission and Distribution of Power through conventional and renewable sources.

Maithon Power Limited (MPL) is a 74:26 joint venture of The Tata Power Company Limited and DVC (Damodar Valley Corporation). MPL owns and operates 2x525 MW capacity, Indian coal based thermal power generation plant based on pulverized coal-based boiler technology. The generating plant is in Maithon near the city of Dhanbad in the state of Jharkhand in India.

## 2. SCOPE OF WORK:

The brief scope of work comprise of Inspection and overhauling of boiler LTSH, economizer & back pass.

Detailed Scope of Work for this Contract shall be provided in the Tender / RFQ document to all potential buyers submitting the valid EOI with due tender fees.

## 3. TENDER FEE & TIMELINES:

a) Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for extension of EOI submission date will be not be entertained.

**d) Expression of Interest letter to be submitted along with tender fee payment details should include the following details:**

- A covering letter duly stamped and signed by an authorized signatory clearly indicating the Tender Reference number and your EOI to participate in the tendering process.
  - Tender fee payment details / reference no (ensure that tender fee is received by us within specified deadline)
  - Bidder to indicate authorized person name, contact number and e-mail id (mandatory) of the person to whom RFQ / tender and all other communications to be addressed for this tender.
- e) Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

#### **4. BIDDER PRE-QUALIFICATION REQUIREMENTS:**

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification requirement / criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.

##### **4.1 TECHNICAL REQUIREMENT:**

- 4.1.1 The bidder should have successfully executed at least two single contracts for **Boiler Pressure part Overhauling for not less than 250MW Unit** of order value not less than Rs. 1 Crores (Rupees One Crores only) each order, during any one of the preceding three years (2021-22, 2022-23, 2023-24).
- 4.1.2 The Bidder should have executed complete replacement of Economizer Coils of Boiler, repair of LTSH top and bottom hangers in situ through Lifting and Lowering method of complete Hangers (top and bottom), In-situ replacement or One to One replacement of Boiler Re-Heater Coils (HRH and CRH), overhauling of boiler front pass of not less than **250 MW as applicable**. Credential/ Record for the same needs to be furnished with the offer.
- 4.1.3 The Bidder should have executed replacement of LTSH Coils of Boiler of not less than 500 MW. Credential/ Record for the same needs to be furnished with the offer.
- 4.1.4 The Bidder should have executed replacement of LTSH top and bottom old hangers with new hangers from boiler. Credential/ Record for the replacement of at least 20 hangers in a single order needs to be furnished with the offer
- 4.1.5 The Bidder should be registered with IBR authorities and approved from Local IBR authorities for execution of the pressure part overhaul order.

##### **4.2 DOCUMENTS REQUIRED WITH BID FOR TECHNICAL CRITERIA**

The bidder shall in his own interest, furnish complete documentary evidence to justify that he meets the 'Bidder Qualification Criteria' as given above. The bidder shall submit the following documents also along with the tender.

- a. Copies of similar type of work orders issued by owner/client (Original)
- b. Copies of completion certificates issued by owner/client (Original)
- c. Approval letter from the local boiler office for execution of pressure parts overhauling work.
- d. List of Jobs undertaken with details and values meeting the above conditions.

#### 4.3 FINANCIAL REQUIREMENT:

- a) Bidder shall have an average annual turn-over of not less than INR 3 Crores during the last three financial years.

#### 4.4 SAFETY and QUALITY REQUIREMENT:

- a) Bidder should preferably have ISO 9001, ISO 14001 and ISO: 45001 certification or must give an undertaking for its willingness to obtain the same within 2 months of qualification for the work.

#### 4.5 SUPPORTING DOCUMENTS (to be submitted with Technical Bid):

- a) PO Copy, Completion Certificate from the concerned client in support of successful execution of jobs /reference projects to be submitted.

- c) Audited Balance Sheet and Profit & Loss Statement with UDIN no.for last three completed financial years reckoned from the date of application.

#### 5. BID SECURITY / EMD (to be submitted along with RFQ and not with EOI)

Interested parties to note that Bidder is required to furnish a Bid Security along with their Bid (only during Bid Submission stage), as a Bank Guarantee (in the format prescribed in Bid Document) or as NEFT/RTGS/DD for an amount of **INR 200,000.00** (INR Two Lakhs only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened

#### 6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties that submitted a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
