- Identify internal & external stakeholders (employees, opinion makers, media, community, District administration, & respective state govts, etc) and understand their expectations for Environment
- Prioritize & identify the areas which need actions based on above and establish goals and targets.
- Get required technological support that promote Environment protection & Conservation by collaborating with research institutes, equipment manufactures & suppliers, peer group & internal expertise

#### 2. Environmental Excellence:

- Ensure effective measures to be a leader in Environmental Performance at national and international level <sup>1</sup> by achieving Carbon Neutrality, Adopting Circular Economy for Water & Waste.
- Spearheading Pro-active approach by employing environmental aspects as one of the prime considerations in decision-making process.
- Identify and manage environmental impacts due to business activities, by adopting possible latest environment management state of art technologies and practices.
- Evaluate performance of Environment protection measures.
- Ensure cost effective and optimal use of resources such as land, water, fuel, construction materials, oils, and chemicals etc, especially the non-renewables.
- Benchmark parameters to establish and adopt best practices.

## 3. Compliance and Assurance:

- Tata Power continue to comply with all relevant environmental regulations, standards and other applicable codes by operating and maintaining the assets within the boundary of permits, consents, and licenses including in new tramendments for various statutory compliance are mapped in the online system called as Legatrix.<sup>2</sup>
- Environmental risks perceived shall be reviewed through Risk Management Committee for appropriate action for reporting environment related parameters, deviations and constraints to Management.
- Shall Undertake regular Environment audits, deliberate & act on recommendations.

## 4. Capacity Building:

- Provide training on Environment related awareness / sensitization for all employees and allied groups (Township / school / community / office, etc.)
- Provide specialized training to focused groups at corporate & station levels to meet policy objectives
- Subscribe and disseminate Environment related study reports, researches, findings, innovations through different media to all employees.
- Encourage discussion platforms such as professional & quality circles focused on water conservation and sustainability issues

# V. Roles & Responsibility

This policy is oversighted by Tata Power Senior Leadership.
