(Compromises, Arrangements and Amalgamation) Rules, 2016, was presented before the Hon'ble National Company Law Tribunal, Mumbai Bench ("**Tribunal**") for sanctioning the proposed Composite Scheme of Arrangement amongst Coastal Gujarat Power Limited and

Tata Power Solar Systems Limited and The Tata Power Company Limited and their respective shareholders (“**Scheme**”).
