

A GROUP of professional footballers, all residents of the satellite township Navi Mumbai, has been sweating it out morning and evening on the back roads of Nerul to keep up their fitness and footwork, as they prepare for the upcoming season under the guidance of coach Sunil Poojari. The sessions are punctuated by the stark reminder of the times we live in — at regular intervals, the boys take breaks, run to their bags, pulling out small bottles of sanitiser to clean their hands.

The Maharashtra government's Mission Begin Again, a phased relaxation of the lockdown, has permitted individual physical exercises like cycling, jogging, running, walking in open spaces. The boys are careful to place their exercise mats at a respectable social distance. They stretch, use free weights for weight-training and run for endurance on the newly laid road as part of the training. A few of them currently play in the

Indian Super League (ISL), a professional football league. A couple of them represent the Indian national team. Just before the season begins every year, this is where the boys congregate and help each other to prepare themselves before they go and practice with their respective clubs. But this year with the gyms closed, this is the first time they are doing the entire range of their fitness regimen here, including weight training.

"Working out together helps in faster development rather than individual preparation. Most of these players are groomed here from the early days of their career. They compete with each other to develop themselves; it gives much faster and better results. The National Team and ISL franchises have individual training programs, we try and prepare a program by merging the training methodologies. The main goal is to do pre-season conditioning for the boys, prepare them in such a way for the up-

coming season, so that when they go to their respective clubs, they start seamlessly training there without facing any problems," explains coach Sunil Poojari.

Nikhil Poojari, who plays for Hyderabad FC and represents the national team, had to stay put at his home for these two months due to the lockdown. He believes that he was lucky as the football season ended before the lockdown was announced in March.

"We were working out at home, unfortunately in Mumbai as we all know our homes are not that big so we will not be able to do much ball work without breaking stuff at home. Furthermore, if one is training individually one tends to give up too soon as the motivation factor is missing. But if one is working with a coach, he will push you to get to the desired goal. It helps us perform better and have fewer injuries during the season," says Nikhil.

This road has been a favourite, as it is level and has a linear aspect. "Earlier, corona-affected cases were less but the fear was more, but as time progressed the known positive cases are much higher but the fear in us has reduced. Even though my parents advised me not to venture out, I have started training. It is risky, but we cannot stay back home in the whole off-season. We need to prepare," says Nikhil.

For Rahul Bheke, who plays for the national team and represents Bangalore FC in ISL, the lockdown has been a good period in which to rest, heal his body and spend extended quality time with his family.

"Every year we do our preparation before the season starts under Sunil sir. Because of the pandemic and the government protocols we couldn't congregate earlier. Our sport has some physical demands and one cannot stay at home and train. To run one has to leave home and be on the field. Had

we waited further, we would have lost more days, and had to rush with our training program. The risk of injury would have been higher. During the last phase of our training when we need to do ball work, we will be moving to a proper ground," says Rahul.

Currently, Nikhil and Rahul apart from joining their respective ISL franchises are preparing to join the national camp for the World Cup qualifiers. The game is scheduled for October-November. Other boys are working hard for a good upcoming season for themselves and the respective clubs they play for.

As of now uncertainty looms large on the final dates for the start of the forthcoming professional football season in India. A few local football leagues have already been called off due to the pandemic. Till then, Sunil and his boys will train hard and prepare themselves, with the 'hood quite oblivious that it is hosting such intense training sessions.

Woman 'duped' of Rs 12.71 lakh by fraudsters on Facebook

Mumbai: A 53-year-old woman, a Walkeshwar resident, was allegedly duped of Rs 12.71 lakh by unknown fraudsters, who befriended her on Facebook and demanded the money on the pretext of sending her cash and expensive gifts from the UK, police said.

According to her complaint to Gamdevi police, the woman received a friend request on Facebook from a man, Kelwyn Megan, in May. "The person was wearing a pilot's uniform in his profile picture, so she assumed that was his profession," an officer said. The two then reportedly began chatting on Facebook and shared phone numbers. The complainant told the police that the latter approached the police and planned to marry her.

The woman told the police that as it was her birthday on June 1, Megan said he was going to send her a gift. On June 1, she got a call from a woman who identified herself as Jayanti Verma. The caller reportedly told the complainant she worked at the Delhi airport and that there is a gift for her from Megan, and asked her to pay Rs 37,850 as a processing fee. Verma reportedly made her pay Rs 12.71 lakh on different pretexts. However, when Verma reached out to the complainant on June 11 asking her to pay another fine, the latter approached the police and a complaint was filed. **ENS**

For five decades, his typewriter spoke for Mumbai, his letters for its people


ANTHONY PARAKAL belonged to a time when the common man wrote letters congratulating Prime Ministers on their appointment — and received handwritten responses. It was a time when a reader's letter to a newspaper's editor spurred the government to act.

Those times may be long gone. And on Tuesday, Parakal, whose typewriter in a one-room Malad residence spoke for the people of Mumbai for over five decades, breathed his last. He succumbed to a cardiac arrest at 89. He is survived by his wife and three children.

In 1993, Parakal's name was included in the Limca Book of Records for having the most number of letters published in newspapers till then: 3,700. By 2005, when fading memory and ill health forced him to forsake that typewriter, he had around 5,000 letters published in his name, according to his son Cherian, who is based in Sharjah.

In fact, Parakal had even typed out a note on giving up writing letters to newspapers after 50 years: "What motivated me to write...is my belief that one should not live for himself but also for others without which we cannot live in a peaceful society."

A stickler for record — there are 16 files full of his published letters — he

also wrote in that final note that his "last social commitment" was getting the height of the Malad railway station platform raised so that people did not fall in the gap between the train footboard and the platform.

That letter, incidentally, was published in The Times of India on December 15, 2003. On January 28, 2014, there was a response from Shaileendra Kumar, CPRO, WR Churchgate: "Apropos the complaint

of Mr Anthony Parakal, the Western Railway will be raising the height of many platforms between Churchgate and Virar. For Malad station, contract formalities are being completed."

Parakal's connection with the Railways was lifelong, starting with his first posting in Jhansi and transfer to Mumbai in 1953. "In Mumbai, he was shocked to see the poor amenities, especially the slums, water supply problems, and diseases like leprosy. This was in stark contrast to the situation in Kerala from where he hailed," says Parakal's son, Cherian, 55.

Cherian says his father's elder brother Kurian was a Gandhian from Narakkal in Kerala who was called "Sarvodayam Parakal" for his social work.

"He would go from house to house, asking people if they needed anything. That is where my father developed a sense of social responsibility. At one point, he was interested in journalism and had learnt shorthand writing. This could have been the reason why he chose the 'Letters to the Editor' column as the means to fight for social issues,"

he says.

With a free Railway pass, Cherian says his father would travel first class on the suburban line where he would get ideas about what subject to choose for the next letter.

"In the free time between Malad and CST, he would jot down the issues in shorthand. Once he returned home, he would take a bath, have food, and pull out the typewriter. He had a particular spot on the sofa where he sat to type out those letters. The next day, during his lunch break, he would drop them in a post box near CST. He was so disciplined that the spot where he sat on the sofa every day was worn out," says Cherian.

The son recalls another peculiarity. "The A-4 letters that he typed did not fit in the envelopes available then. So he would make his own envelopes," he says.

Parakal's file also included congratulatory messages sent to Prime Ministers, from Morarji Desai to Rajiv Gandhi, and their replies.

"We used to enjoy it. Sometimes, by the end of the month, when cash was short, our mother would threaten to burn the letters. But she was actually very supportive, and took tuition at home to support the family," says Cherian.

"As people came to know about his letter-writing, many from all over the city started coming to our house with their issues. He would ignore us, but never the person who came home with a grievance."

CM asks agencies to fill potholes, repair roads immediately

CHIEF MINISTER Uddhav Thackeray on Saturday instructed the BMC to set up a panel of all the government agencies and immediately fill up potholes and complete road repair works across Mumbai.

During a review meeting, held through video-conference, Thackeray asked the agencies to ensure proper coordination to tackle the rising Covid-19 cases and other monsoon-related diseases. The chief minister asked the BMC to hold a meeting with all agencies, including MMRDA, PWD, Metro, Mumbai Port Trust, and the Railways, to fast-track all the monsoon-related works in Mumbai. "A joint panel of all agencies should be set up and a mechanism should be created that will ensure the immediate pothole-filling and road-repair works even if the roads come under the jurisdiction of different agencies," Thackeray said.

Roads in Mumbai fall under the jurisdiction of various agencies such as BMC, MMRDA, and PWD, among others. So far, there has always been a blame game between the Shiv Sena-ruled BMC and other agencies over the pothole repairs works. With Thackeray heading the state, the idea of setting up the joint panel of all agencies assumes significance as the Sena may no longer be in a position to pass the buck.

In the past, Sena has stressed on sharing

road maintenance work among different agencies. In 2011, Thackeray, then the Shiv Sena executive president, had called for "dissolving" the MMRDA headed by the then chief minister Prithviraj

Chavan, which was responsible for maintenance of some bridges, flyovers and roads under the Metro and monorail projects. In 2018, the party had staged a protest blaming the BJP for the poor condition of roads under the PWD and the MMRDA.

"Every year there is a new committee, which promises to look into the complaints on potholes and there aren't any results. BMC needs to inspect the quality of road under their jurisdiction first to check why potholes reoccur after first showers in the city every year," said Prabhakar Shinde, BJP corporator and leader of opposition in the BMC.

Dadar-based activist Nikhil Desai, meanwhile, said the new committee would become another excuse to pass the buck. "Majority of road length, nearly 1,800 km, is under BMC's jurisdiction. They should look into maintaining these roads and keep them pothole-free," he said.

In 2017, the Bombay High Court had formed a two-member committee to look into repair and maintenance of roads. Based on the suggestion of the panel, BMC each year publishes a list of WhatsApp contact numbers of road engineers where citizens can submit complaints on potholes. People can also register complaints on a mobile application, 'MCGM 24/7', and on toll-free 1800221293, between 9 am and 9 pm.

During the meeting, Thackeray also emphasised on the need of proper planning while stating that fever, cough and cold cases could go up during the monsoon.
