Clear attempt to demoralise state police, govt tells HC

EXPRESS NEWS SERVICE MUMBAI, OCTOBER 28

THE MAHARASHTRA government informed the Bombay High Court on Thursday that there seems to be an attempt to "demoralise the police force of the state", some officials have been summoned by the Central Bureau of Investigation (CBI) in connection with its probe against former state home minister Anil Deshmukh, despite the pendency of the case before the court.

"They have continued to issue summons to various police persons. This is a clear attempt to demoralise the police force. We are seeking protection, there should be no coercive action taken. These are all police officers," senior counsel Dhanu Khambatta, representing the state government told HC.

A division bench of Justice Nitin M Jandkar and Justice Sarang V Kotalwar was hearing a petition filed by the Maharashtra government against summons issued to state Chief Secretary Sitaram Kunte and Director General of Police Sanjay Pandey by the CBI in connection with its probe. The bench said that it was not getting into the merits of the case at the present stage. It added that fresh summons to the officials can be issued be-

eyond the date of the hearing of the petition on November 17. Khambatta told the court that the CBI had said that it wanted a file response to the petition after he had completed his arguments during the last hearing.

"They (CBI) have issued two notices on October 18 and 19 while the matter was being argued. They are the ones who have taken time to file a reply but have suddenly sprung into action now. These are police officers, who are all doing their duty. Any action of this nature, there is a threat that if you do not attend, there will be consequences. The DGP who has been summoned was admittedly not concerned at the relevant time; yet he is summoned; the chief secretary too has been summoned," Khambatta told the court.

Additional Solicitor General Aman Lekhi, representing CBI, said he could not make any statement on protection for his officers, but the CBI would ensure that fresh summons are issued beyond the date of the court hearing.

ED searches residence of Ajit Pawar's cousin

THE ENFORCEMENT Directorate on Thursday searched several places in Mumbai and Pune, including the Pune residence of Jagdish Kadam, cousin of Maharashtra Deputy CM Ajit Pawar, in connection with its probe into the alleged Rs 25,000-crore fraud at Maharashtra State Co-operative (MSC) Bank.

Kadam is a director at Daund Sugar Private Limited, a company that has come under the scanner of ED in the case. The ED case pertaining to the alleged fraud at MSC Bank originates from a PIL filed on January 28, 2019 before the Bombay High Court. The PIL has alleged that then top executives - chairman, MDs, directors, CEOs and managerial staff - of MSC Bank as well as office-bearers and directors of Sakhar Karkhanas, Soot Gimis and other processing units, were given loans in a fraudulent manner by the bank.

In September 2019, a month before the Maharashtra Assembly polls, the ED had registered a money laundering case against NPCI Chief Sharad Pawar and his nephew Ajit Pawar in connection with the alleged scam. On October 7, the income tax had searched the directors of four sugar mills in the state, including Daund Sugar, for alleged evasion of taxes. Subsequently, on October 16, the department, in a statement, without naming Pawar or his kin had said that it has unearthed unaccounted income of Rs 184 crore from its October 7 searches. On Thursday, he held a meeting of the steering committee on the preservation and conservation of forts and also reviewed the six forts selected in the first phase for conservation and preservation earlier this year: Shivneri, Rajgad, Torna, Vijaydurg, Sinhadurg and Sinhgad forts.
