Land acquisition delay to escalate cost of bullet train project in state: ministers

MUMBAI, JUNE 6

ASHWINI VAISHNAW, Union Railway Minister, inspected the ongoing work on the Mumbai-Ahmedabad bullet train project in Surat on Monday and said that the cost of the project is expected to escalate in Maharashtra due to the delay in the land acquisition and commencement of the work.

The estimated cost of the Mumbai-Ahmedabad bullet train project is Rs 1.08 lakh crore of which 81 per cent is funded through a loan from the Japan International Cooperation Agency (JICA).

Vaishnav also announced that initially, the bullet train service will commence on the 51-km stretch in Gujarat between Surat and Bilimora by 2026 even if the work in Maharashtra is not complete.

While the Central government has put the onus on the state government to complete the work in starting work, the project

seems to have also been delayed by over four years in Gujarat. The initial deadline for completion of work on the 508-km project was 2022 and, however, the deadline kept extending and now the first phase of the project, a 51-km stretch between Surat and Bilimora in Gujarat is likely to be operational only in 2026 and the remaining part of the land in Gujarat is expected by 2028.

has been unable to acquire land owned by the state government or the forest department. This constitutes the remaining part of the land requirement for the project.

Since the work contract cannot be awarded until 90 per cent of the land acquisition is complete, there is a delay in handing over the land in BK and other parts of Mumbai to start work. The delay in the land acquisition of the land of BK, the NHRSC had recently cancelled the tender for the construction of terminal at BK after several extensions.

"The work in Maharashtra will start once the state government is clear on the intent of the state government as also a time that the people of Maharashtra should speak and think about it as the people of the state want the bullet train project and we are now hoping that the state government will also be convinced soon. We are open to discussing with the state government on the issue they wish to discuss and

sort it out," Vaishnav said. When asked if the cost of the project on the Gujarat section will also be escalated as there has been a delay, the railway minister said the costing will be reviewed soon to ascertain the escalation.

The project has been opposed by the Maharashtra Chief Minister and Shiv Sena Chief Uddhav Thackeray, who during his earlier tenure in the state government had clearly said that the people of Maharashtra do not need the project as the Ahmedabad-Mumbai route is not useful for Maharashtra. He had demanded a bullet service train between Mumbai and Nagpur stretch.

Giving details about the project, Vaishnav said that till now, 100 km of track has been constructed in more than a 61-km stretch and more is being carried out simultaneously on a 160/170-km stretch. Every month, more than 10-12 km of piers are being constructed, including bridges on rivers, he added.

Police adds SC/ST Act in FIR against man held for sexual assault on minor

DAYS AFTER a 51-year-old policeman was arrested for alleged sexual assault on a five-year-old girl studying in a school in the eastern suburbs of the city, the Mumbai Police have now added Sections of the Scheduled Tribes/Prevention of Atrocities Act, 1989 in the FIR.

Police said that the incident of sexual assault took place on May 23 when the girl was playing in the school playground. The accused brought the girl into the school by offering her chocolate. He then took the girl to one of the rooms where he allegedly assaulted her sexually before fleeing from the spot.

When the girl reached home, she informed her parents about the incident following which they rushed to the school. After alerting the school authorities, the parents went to the local police station where an FIR was registered.

The FIR was registered under Sections 376 (rape) and relevant sections of the Protection of Children from Sexual Offences (POCSO) Act.

"We will soon file a chargesheet against him under the IPC, POCSO Act and the Prevention of Atrocities Act," said an investigator.

Cyber fraudster poses as Army captain, dupes man of Rs 1.50 lakh

A 45-YEAR-OLD man who had put up an online advertisement to rent his vacant flat in Pune was duped of Rs 1.50 lakh by a cyber fraudster who impersonated an Army official on the pretext of making an advanced payment.

The complainant works as a sales executive in a property consultancy company in MIDC. He is 82-year-old father who has a flat in Pune but recently moved with the complainant and the family. He decided to rent out the flat in Pune.

On June 3, he gave online advertisements on 99acres.com, MagicBricks and NoBroker. He received a phone call from a person from an Army office, who was interested in renting the flat.

The caller asked the complainant to send photos and videos of his flat. Afterwards, the caller said he is ready to rent the

flat and introduced himself as a Captain in the Indian Army police said. He agreed to pay Rs 45,000 rent and Rs 1.50 lakh deposit.

The caller then sent him an Aadhaar card, PAN card and driving licence in the name of a person from Andhra Pradesh. He also sent the Army's identity card, including his photo with the same name, police said.

The caller then said he has a smart card and asked the complainant to send it. He said that he would receive the money back. The complainant sent him Rs 10 and soon after received Rs 10 in his account. The caller then asked him to send Rs 45,000 for "security deposit" and the family decided to rent out the flat in Pune.

The complainant sent the money but did not receive the same amount back. The caller told him there was a technical error. The family made a complaint deposit a total of Rs 1.50 lakh in three transactions. He then switched off his phone. The complainant then approached the police.

Mumbai Police chief gets new office after 100 years

AFTER MORE than a century, the seat of the Commissioner of Mumbai Police shifted location and moved from the first floor of the Anglo-Gothic style heritage building to the second floor, where incumbent Sanjay Pandey inaugurated the new Commissioner's office on Monday.

According to several officers, the Police Commissioner's office has remained on the first floor of the three-storey building designed in neo-classical Victorian Gothic style by architect John Madson and architect John Adams since 1899.

Before 1899, the Mumbai Police Commissioner's office was located in Byculla from 1880 to 1899.

The current head office of the Commissioner of Police, Greater Mumbai was located at the junction of Lokmany Tilak Marg and Dr Dadabhai Naorojee Road.

The construction of the current building commenced in November 1894 and was completed on December 24, 1896. The site was chosen originally by the then Commissioner Sir Frank Souter because it was far more

convenient than the Old Police Office at Byculla—and also for containing reinforcements during seasons of popular excitement and disturbance, as per the Mumbai Police Chief.

The website further says, "However, Souter retired before the building was ready, and the honour of being the first commissioner to occupy it went to Hartley Kennedy, CSI, Commissioner during 1899-1901. Although the building was ready at the end of 1896, it was only on January 9, 1899 that Kennedy moved in."

According to senior officers, ever since the office moved to Crawford Market, the Commissioner's office has been on the first floor of the building. Over the years, two more buildings have come up in the Commissioner's office, including one six-storey building in 2015 where the Mumbai Police Control room is located.

An officer said the office that has been vacated by the Commissioner will soon be occupied by the Mumbai Police Control room (crime), as there is a proposal to demolish the structure where the latter's office is located, and another six-storey building likely to come up in its place.

'Merely following the law': Pandey denies MVA bias allegations

RESPONDING FOR the first time to allegations by several BJP leaders that he has been denied the Mumbai Police Commissioner by the Maha Vikas Adhikari (MVA) government to take on opposition leaders, Sanjay Pandey on Monday denied the charges and said the move was merely following the law.

Speaking at a media briefing to mark the inauguration of the new Mumbai Police Commissioner's Office on Monday, Pandey said, "All the cases were registered on the basis of complaints coming forward. We just followed the due process of registering complaints and filing chargesheets, which is the natural process of investigation."

When asked about the Mumbai Police continuing with the probe in the FIR against BJP leader Mohi Kamboj despite the manager of the Indian Overseas Bank withdrawing his complaint, Pandey said, "You have to understand the process of law. Within 24

hours of registering an FIR, it has to be sent before a magistrate. The matter then goes before the magistrate. So, if someone wants to withdraw a complaint, it has to be done before the magistrate. We cannot probe matter and then withdraw a complaint. The process is being followed and as per procedure, she will be summoned and her statement will be recorded in the matter."

When asked if the summons had been issued, Pandey said he was not aware of the same.

On the status of the probe in the Salman Khan case, the police chief said that the department had taken serious cognizance of the incident and that investigation is in progress.

Pandey, who has been vocal about the "harassment" of homes by housing companies in the past, spoke on the issue again and said that housing societies need to rethink about how they function.

CIVIC POLLS IN 236 SEATS BMC receives over 200 suggestions, objections over reservation draw

THE BRIHANMUMBAI Municipal Corporation's (BMC) election department has received 232 suggestions and objections from citizens as well as political parties on reservation draw for 236 electoral seats held recently for the upcoming city elections.

According to officials from the department, about 90 per cent of feedback was received on Monday—the last day for raising the suggestions and objections.

A senior official from the BMC said that ward-wise final reservation will be published on June 13 in the state gazette. While the reservation draw for 236 electoral wards was held on May 31, the citizens were allowed to send their suggestions from June 1 to 6. As per data from the election department, while 25 suggestions and objections were received from June 1 to 5, remaining 207 were received on the last day.

"No hearings will be conducted on the suggestions and objections. The concerned local

bodies will thoroughly examine and discuss the suggestions and objections. Then, based on their assessment of the suggestions and objections, a decision will be taken regarding retaining or changing the ward reservation. The final list of electoral wards with reservations will be published on May 13," said an official from the State Election Commission (SEC).

Earlier in the last week of May, the SEC had issued orders to 14 municipal corporations including the BMC, to hold the reservation lottery on May 31, without OBC seats.

The reservation lottery had upset many senior corporators and big names across party lines. A number of prominent names such as former standing committee chairman Yashwant Jadhav, former Sena corporator Amey Ghole and Ashish Chemburkar, former BJP corporators Prabhakar Shinde and Vinod Mishra, former opposition leader Ravi Raju and former Congress corporator Ash Zalkaria have found themselves impacted by the process.

In February, the BMC, then controlled by the Shiv Sena, conducted the reservation lottery and increased the number of electoral wards from 227 to 236 and changed the ward boundaries.
