FIRST OFFICIAL TRIP TO NEW ZEALAND

India pressed Russia on safety of Ukraine N-plant: Jaishankar

INDIA IS willing to do whatever it can to facilitate a solution to the Ukraine crisis, External Affairs Minister S Jaishankar said on Thursday, as he highlighted how India pressed Moscow on the safety of the Zaporizhzhia nuclear power plant in Ukraine when the two countries stepped up fighting near the highly sensitive facility.

Jaishankar, who is in New Zealand on his first visit as External Affairs Minister, made the comments during an interaction with Simon Bridges, the CEO of Auckland Business Chamber. The EAM said that when it comes to Ukraine, it is natural that different countries and different regions would re-

their threat perception, their anxiety, their equities in Ukraine," he said. In this situation, Jaishankar said he would see what India can do, "which obviously would be in the Indian interest, but also in the best interest of the world." "When I was in the United Nations, the big concern at that time was the safety of the Zaporizhzhia nuclear power plant because there was some fighting going on in the very proximity to it. There was a request to us to press the Russians on that issue which we did. There have been other concerns at various points of time, either different countries have raised with us or the UN has raised with us. I think at this time whatever we can do, we will be willing to do," Jaishankar said.

"If we take up a position and voice our views, I don't think countries would disregard that, and that we were visible in a meeting between my Prime Minister (Narendra Modi) and President (Vladimir) Putin," he said, referring to the meeting between the two top leaders in Asthana on the sidelines of the Shanghai Cooperation Organisation on September 16. Jaishankar also talked about India's aspiration to become a permanent member of the UN Security Council, saying big problems of the day cannot be solved by one, two or even five countries. "And when we look at the reforms, we have an interest in becoming a permanent member of the security council. It is also because we think in different ways and we voice the interests and aspirations of a broad set of countries," he said.

Fall of gloom descends in village of Sikh family murdered in US

THE DEATH of four members of a Sikh family kidnapped at gunpoint in California has left their relatives in Punjab completely devastated. The parents of the deceased woman who live in Punjab were overwhelmed by feelings of depression. A pall of gloom descended on the house as villagers thronged their place on Thursday to console them. Most of the villagers were in a state of shock as they could not imagine that such things could happen in a country like the US. All four Sikh family members, including an eight-month-old baby girl, who were kidnapped from their newly opened trucking business in Merced County, California, on Monday were found dead in an orchard, authorities said on Wednesday. The sheriff of Merced County

on Wednesday night said that a farmworker found around 5.30 pm (California time) in an orchard the bodies of Jasdeep Singh (36), his wife Jasleen Kaur (27), their eight-month-old daughter Aroohi Dheri and Jasdeep's brother Amandeep Singh (39). The announcement came after the authorities released a surveillance video of a man kidnapping them from their business place on Monday. At Jasleen's native village Jandir in Jalandhar, her sister-in-law Amandeep Kaur has been inconsolable since the bad news came. Jasleen's mother Gurmeet Kaur and her former father Gurnam Singh were not in a mental state to speak. They just uttered a few words that they could not see their daughter ever since she went to the US two years ago, and now they would never be able to see her again. The parents are yet to take a decision about their visit to the

US to attend the last rites as they have been in a state of deep shock since the kidnapping three days ago. Jasdeep was hoisted from Harsi Pind village in Hoshiarpur and his parents Randhir Singh and Kirpal Kaur returned to the US on Tuesday night. They are also based in US and had come to India for a pilgrimage to Uttarakhand during which they came to know about the kidnapping incident. Charanjit Singh, a cousin of Jasdeep Singh, demanded justice for the family. Gurnam Singh said that his daughter (Jasleen) got married to Jasdeep in January 2019 and went to the US in October 2020. "My daughter had informed us recently that they are planning to visit us in January 2023 and we were anxiously looking forward to see our granddaughter first time since she was born and had planned to celebrate the arrival of our granddaughter who

would have turned one at the time of their visit in India," he said, adding that he has no clue why and how it had happened. He said that Jasleen's in-laws had shifted to the new office at Merced around two weeks ago. "Her in-laws came to Punjab last month and also visited us in Jandir," he added. Meanwhile, the California police arrested one suspect, Jesus Manuel Salgado (48), after he used the ATM card of one of the victims. Salgado attempted suicide and he was hospitalised. Later, the police released a surveillance footage showing the victims being led out of the business by an armed man. The video showed the suspect first walking by the property before talking to one of the men. Later, it shows him leading the men, who had their hands zip-tied behind their backs, into the back seat of Amandeep Singh's pickup truck.

UTTARKASHI AVALANCHE: 12 MORE BODIES FOUND, 13 STILL MISSING

There was little we could do, says survivor; death count rises to 16

TWELVE MORE bodies were recovered Thursday from the site of an avalanche that hit a team of climbers in Uttarakhand's Uttarkashi district, officials said, taking the death toll to 16. A 41-member team of climbers, comprising 34 trainees and 7 instructors, from the Nehru Institute of Mountaineering (NIM), was trapped after the avalanche at Draupadi ka Danda-2 (DKD-2) peak on Tuesday morning. While 12 team members were rescued, 13 are still missing. According to a bulletin issued by the Nehru Institute of Mountaineering (NIM), of the 16 bodies recovered so

far, 14 were of trainees and two of their instructors. Officials said the evacuation of the bodies from the avalanche site, which was stopped due to bad weather, will resume Friday morning. One of the survivors, Naib Subedar Anil Kumar told The Indian Express the team was out trekking as part of the advance training course conducted by the NIM. "The 28-day course started on September 14 and in the first few days, the trainees are given a refresher of their basic course and then the advanced training. The last leg of the training included staying at a camp set up near the Dokriani Bamak glacier for around 10 days and then climbing the DKD-2 peak... where mountaineers have been going for the last 50-55

years," said Kumar, an instructor. Giving further details, Kumar said that on Tuesday, prepared for the tough climb, the 41 left camp-1 around 3.15 am after the weather cleared. The plan, he said, was to reach the DKD-2 summit by 8 am and return by 10 am. "Trekking during sunlight is very unsafe as it weakens the bonding between the ice. The reflection of sunlight from the ice can also cause exhaustion. Around 7.45 am, I reached the peak along with another member of the team. We decided that in the next 15 minutes we will stop wherever we are and start returning," Kumar said. Soon, however, with another group of climbers around 15-20 metres from the summit, there was a sudden slab avalanche.

Fortnight after rape, UP teen dies by suicide

MORE THAN a fortnight after she was allegedly abducted and gangraped, a 13-year-old girl died by suicide in Ambedkar Nagar district of Uttar Pradesh on Wednesday. With her family alleging that she took the step due to alleged police inaction in the gangrape investigation, the district police administration on Thursday removed the in-charge (SHO) of the police station concerned and sus-

pected the investigating officer for alleged dereliction of duty. Police also arrested two persons, including the teenage girl's aunt, for allegedly being complicit in her abduction. The girl was allegedly kidnapped by two persons when she was on her way to school on the morning of September 16. Two days later, the teenager returned home and told her family that she had managed to escape from her captors in Lucknow. She was allegedly raped by the two persons

who had taken her to a hotel in Lucknow. The two are yet to be identified, police said. Deputy Inspector General (Ayodhya Range) Amrendra PD Singh said, "One of the arrested persons is the girl's aunt. The other is a 35-year-old man who knew the girl and her family. He was present when the two persons kidnapped the girl. The aunt helped in the abduction. I can't divulge more details as the probe is on. We will share more details as the investigation makes progress." The two arrested

officials too had told other officials that if those who raped her were not caught, she would kill herself. "The men took her to Lucknow and raped her. I reported the incident to the police but nobody paid heed. The policemen used to come and enquire about what had happened," added the family member. The girl was said to have hanged herself in her house. The last rites were performed by her family members on Thursday after a post-mortem examination.

भारतातील सेवा व्यवसायातील खरेदी व्यवस्थापकांचा कल दर्शावणाऱ्या 'एस अँड पी ग्लोबल इंडिया सर्व्हेस पीएमआय' निदेशांक सप्टेंबर महिन्यात ५४.३ गुणांवर

नोंदवला गेला. ऑगस्टमधील ५७.२ गुणांच्या तुलनेत या निदेशांकात जवळपास २.९ गुणांची पडझड झाली आहे. मासिक तुलनेतील ही आकडेवारी वर्तमान परिस्थितीत सेवा क्षेत्रापुढे काही आव्हाने असल्याचे दर्शविणारी असली, तरी सलग चौदाव्या महिन्यात सेवा क्षेत्रातील उत्पादनाचे विस्तारदर्शक कल दर्शविला आहे.
