करदात्यांच्या वैयक्तिक उत्पन्नात वाढ झाल्याने चालू आर्थिक वर्षातील पहिल्या अकरा महिन्यांमध्ये १० फेब्रुवारीपर्यंत देशाचे एकूण प्रत्यक्ष कर संकलन २४ टक्क्यांनी वाढून १५.६७ लाख कोटी रुपयांवर पोहोचले आहे. गेल्या वर्षी याच काळात तो १२.६३ लाख कोटी रुपये नोंदवला गेला होता. परतावा समायोजित केल्यानंतर, निव्वळ प्रत्यक्ष कर संकलन १२.९८ लाख कोटी रुपये नोंदवले गेले आहे, जे मागील वर्षीच्या याच कालावधीतील निव्वळ संकलनापेक्षा १८.४० टक्क्यांनी अधिक राहिले आहे, अशी माहिती केंद्रीय अर्थमंत्रालयाने शनिवारी दिली.

एकूण सुधारित अंदाजपत्रकाच्या ७९ टक्के निव्वळ संकलन आहे. केंद्र सरकारने या आर्थिक वर्षात १४.२० लाख कोटी रुपयांच्या प्रत्यक्ष कर संकलनाचा अंदाज अर्थसंकल्पात वर्तविला होता. नंतर तो वाढवून १६.५० लाख कोटी करण्यात आला. व्यक्तिगत प्राप्तिकर, कंपनी कर, संपत्ती कर आदींचा समावेश असलेल्या प्रत्यक्ष कराचे सरकारचे संकलन सरलेल्या दहा महिन्यांच्या कालावधीत दुहेरी अंकांने वाढले आहे. १ एप्रिल ते १० जानेवारी दरम्यान कंपनी कर १९.३३ टक्क्यांनी तर व्यक्तिगत प्राप्तिकरात २९.६३ टक्क्यांनी वाढ झाली आहे.

रायगड जिल्ह्यात खरीप



मौगोलिक मानांकन मिळाल्याने पांढऱ्या कांद्याला मागणी वाढली आहे. मुंबई-पुण्यासारख्या महानगरातून कांद्यासाठी मोठी मागणी केली जात आहे. यंदा हवामान चांगले होते. त्यामुळे पीकही जोमाने आले आहे. कांद्याच्या काढणीला सुरुवात झाली असून येत्या काही दिवसांत कांदा बाजारात मुबलक प्रमाणात दाखल होईल. -जयेश भास्कर पाटील, शेतकरी, कार्ले

हंगामात भात पिकाची मोठ्या प्रमाणात लागवड होत असते. मात्र रब्बी हंगामात सिंचन क्षेत्र वगळता फारशी पिके घेतली जात नाहीत. जिल्ह्यात ओलिताखालील क्षेत्र फारसे नसल्याने दुबार आणि तिबार शेती जवळपास केली जात नाही. पण अलिबाग तालुका त्याला अपवाद ठरतो. भात कापणीनंतर जमिनीतील ओलावा दोन महिने टिकत असल्याने अलिबाग

तालुक्यात पांढरा कांदा यासारख्या पिकांची लागवड केली जाते. ज्यातून चांगले उत्पन्न शेतकऱ्यांना मिळते. या कांद्याला वाढती मागणी आणि चांगली किंमत मिळत असल्याने गेल्या काही वर्षांत लगतच्या गावात पांढऱ्या कांद्याची लागवड केली जाऊ लागली. मागील वर्षी २२३ हेक्टरवर पांढऱ्या कांद्याची लागवड करण्यात आली

होती. यावर्षी पांढऱ्या कांद्याच्या लागवडीचे क्षेत्र वाढले आहे. यंदा अलिबाग तालुक्यात २४५ हेक्टर क्षेत्रावर पांढऱ्या कांद्याची लागवड करण्यात आली आहे. यंदा पाउस उशिरापर्यंत पडल्याने पाणी मुबलक होते. पांढऱ्या कांद्याचा आकार मोठा असेल. त्यामुळे शेतकऱ्यांच्या उत्पन्नत

वाढ होणार आहे. सध्या लहान कांदा १५० रुपये माळ तर मोठा कांदा २५० रुपये माळ अशा दराने पांढरा कांदा विकला जात आहे. सुरुवातीच्या हंगामात कांद्याचे दर चढे राहतील, नंतर आवक वाढल्यावर हे दर कमी होतील अशी अपेक्षा आहे. पांढऱ्या कांद्याचे औषधी गुणधर्म अभ्यासकांच्या माहितीनुसार या कांद्यात औषधी गुणधर्म आहेत. कांद्यात मिथाईल सल्फाईड आणि अमीनो अॅसिड हे घटक असतात. ज्यामुळे कोलेस्टेरॉलचे प्रमाण नियंत्रित राहण्यास मदत होते. पोटातील उष्णता कमी होण्यासाठी कांदा उपयुक्त ठरतो. रक्ताचे प्रमाण वाढण्यास मदत होते. जर सर्दी किंवा कफची समस्या असेल तर ताजा कांद्याचा रस गूळ व मध टाकून प्यायल्यास ही समस्या दूर होते.
