Court rejects bail plea of court clerk arrested by ACB

Mumbai, November 24

A SESSIONS court on Monday rejected the bail plea of a court clerk-cum-typist arrested by the Anti-Corruption Bureau (ACB) allegedly after he was caught red-handed while accepting Rs 15 lakh as a bribe. The ACB had opposed the bail plea of Chandrakant Vasudev, citing that if he is released, he may meet his co-accused, an additional sessions judge, who is yet to be arrested.

The ACB told the court that the proposal for action against the judge is pending before the Bombay High Court.

The clerk had allegedly claimed to have collected the bribe, with part of it to be given to the judge for a favourable order in a land dispute case.

Special ACB judge Shayana Patil rejected the plea of Vasudev, with the detailed order yet to be made available.

Earlier in the day, Vasudev's lawyer, Vijay Desai, had submitted before the court that his further custody was not needed as the ACB had collected all the electronic evidence in the case, including his phone, memory cards and voice samples. He also submitted that the ACB's apprehension that if released, Vasudev may tamper with evidence

cannot be accepted as all the necessary evidence have already been collected. He also said that the court can put restrictive conditions on him if there are any other apprehensions.

Additional public prosecutor Prabhakar Tarange opposed the plea stating that the prima facie evidence shows that Vasudev had approached the complainant, sharing his number to seek a bribe for a favourable order.

He said the messages between Vasudev and the judge show that the latter had informed him to come to his home the next day, and given instructions including that the front door may be locked. The prosecutor said that the ACB's proposal for action against the judge remains pending in the high court and there is prima facie proof about his involvement which needs to be probed. The prosecutor said that both the accused need to be interrogated together on the calls and messages between them and their roles.

"The case is linked to the judiciary, people impose a lot of trust in the judiciary...there have been similar cases in the past, including in Satara recently. If appropriate action is not taken, it may lead to erosion of trust among the people," the prosecutor told the court.

CIVIC ELECTIONS

BJP to reserve 40% tickets for candidates under 35: CM

AT LEAST 40 per cent of tickets in the upcoming civic polls will be given to candidates below the age of 35 years, Chief Minister Devendra Fadnavis announced on Monday.

Fadnavis made the announcement during an interactive session at the 'Youth Connect' event held in Mumbai. The local body elections in the state will take place in three phases starting December 2. The formal announcement for polls to the 29 municipal corporations, including the BMC, is still awaited.

Urging young people to enter politics, Fadnavis said, "I can say with absolute certainty that 40 per cent of candidates contesting civic polls will be under 35 years in BJP."

Expressing concern over criminal candidates in politics, he added, "It somewhere also reflected the society at large. And efforts will have to be taken to ensure good people get into politics. Though there are some wrong people in politics, it would also be wrong to call everybody in politics criminal and corrupt."

Citing the example of the central government under Prime Minister Narendra Modi, Fadnavis said, "In the last eleven years of rule under Modi's leadership there is not a single

charge of corruption against the government. The fact that our country is progressive at such a rapid pace, shows the system is functioning. And everything is not rotten." Public participation, he said, is essential for democracy to thrive.

"From 2009 to 2014, corruption was the mainstay of the system. And India got a bad name. The people fed up with the corruption voted for Modi to bring a change in the country," Fadnavis also pointed out that the criminal justice system does not distin-



guish between cases filed against politicians for protests or agitations and those relating to normal crime.

Referring to a 2016 report, he said, "A report stated amongst the chief ministers

facing maximum complaints was Arvind Kejriwal and myself. All the cases against me were for protests for rights of the people or related issues. There was not a single instance of crime or immoral act."

Four Borivali flats attached in PNB fraud case handed over to liquidator

THE ENFORCEMENT Directorate's (ED) Mumbai Zonal Office has facilitated the handing over of four flats in a Borivali project, attached in the case against diamond trader Mehul Choksi and others in the Punjab National Bank (PNB) fraud, to the liquidator on November 21. The liquidator will now proceed with monetisation for the benefit of victims, secured creditors and other legitimate claimants, an official said.

So far, immovable and movable properties located in Mumbai, Kolkata and Surat worth approximately Rs 310 crore have been handed over to the liquidator of Gitanjali Gems Ltd, the firm linked to Choksi, the official added.

To expedite restitution of properties to the victim banks, the ED and the banks agreed on a common stand and moved the Special PMLA Court, Mumbai, with a joint application. The court directed the ED to facilitate banks and liquidators of various Gitanjali Group companies in carrying out valuation and auction of attached or seized properties. After the auction, the sale proceeds are to be deposited as fixed deposits in PNB/ICICI Bank.

ED's investigation under PMLA revealed that Mehul Choksi, along with his associates and Punjab National Bank officials, allegedly fraudulently obtained Letters of Undertaking and Foreign Letters of Credit between 2014 and 2017, causing a wrongful loss of Rs 6,097.63 crore to PNB. Choksi had also taken a loan from ICICI Bank and defaulted on it.

During the probe, the ED conducted searches at more than 136 locations across India and seized valuables and jewellery worth Rs 597.75 crore belonging to the Gitanjali Group. Further, immovable and movable assets worth Rs 1,968.15 crore, comprising overseas and domestic properties, vehicles, bank accounts, factories, shares of listed companies, and jewellery, were attached. In total, assets worth Rs 2,565.90 crore have been attached or seized in the case, and three prosecution complaints have been filed.

DEMANDS ACTION AGAINST LODHA

Due process not followed in Malwani demolition: Congress

THE MUMBAI Congress on Monday alleged that the recent demolition drive in Malwani area was carried out without following due procedures and based on "incorrect" claims that the demolished structures belonged to Bangladeshi or Rohingya nationals.

At a press conference in Mumbai, AICC secretary and Mumbai Congress chief spokesperson Sachin Sawant demanded action against state Minister Mangal Prabhat Lodha, claiming that the latter had directed officials to carry out the drive.

Earlier this month, the authorities had demolished several structures in Malwani, which they claimed were "un-

authorised". Lodha, Mumbai Suburban's Guardian Minister, had claimed that Congress MLA Shaikh had been encouraging the "infiltration" of Bangladeshi and Rohingya nationals in Malwani and thereby playing with the country's security.

On Sunday, BJP workers held a protest demanding action against Shaikh, alleging that the Congress MLA threatened Lodha over the matter. During the press meet, the Congress presented several Hindu and Dalit families, who said their homes were demolished during the operation.

Sawant said the party's assessment indicated that residents from multiple communities had been affected and the demolished homes had existed for over two decades.

"Residents were not given

notice or an opportunity to present documents," Sawant alleged, adding that the procedure outlined under the Supreme Court's guidelines had not been followed.

Sawant claimed that minister Lodha had directed officials to carry out the drive, even as he does not hold charge of the Revenue Department.

Sawant claimed that the complaint that triggered the demolition was submitted by a BJP member, who himself facing criminal cases, and added that the matter required an investigation.

He sought the suspension of officials involved and the removal of Lodha from the Cabinet.

Lodha and the state government officials are yet to respond to Congress' allegations.

If SEC cannot grant extension, defer civic polls: Aaditya, Raj

SHIV SENA (UBT) MLA Aaditya Thackeray and MNS chief Raj Thackeray on Monday mounted a sharp attack on the State Election Commission (SEC), alleging massive irregularities in the draft voters list for the upcoming BMC elections and demanding that the period for filing objections be extended from the present seven days to at least 21 days.

Both leaders said if the SEC cannot grant the extension, the civic polls should be deferred.

Aaditya, who met SEC officials along with a joint Sena (UBT) and MNS delegation, claimed that the scale of errors in the draft rolls pointed to deliberate manipulation rather than clerical lapses. "Repeated names, twice, thrice and even up to seven times, have crossed a million. There are 26,319 households with more than 10 voters registered to a single address, some showing more than a thousand voters in one 10x10

room," he said. He added that nearly seven lakh voters did not have house numbers or complete address details. "This is fraud, not error. If the EC is serious about free and fair elections, these must be corrected," he said.

Raj Thackeray, in a strongly worded letter submitted to State Election Commissioner Dinesh Waghmare, accused the SEC of functioning without transparency and failing to adhere to its own timelines. He pointed out that the last valid voter list was published on October 30, 2024, after which the mandatory annual and quarterly revisions were skipped. "If this is not intentional, what is the reason? The draft list published now is full of confusion—no clarity on gender, addresses or basic details," Raj wrote.

The joint delegation met Waghmare on Monday and handed over Raj's letter, calling the situation 'disgraceful' and demanding immediate corrective action.

गुन्याबद्दल काहीही आठवत नाही, असा दावा केला आहे. त्याला मानसिक झटके येतात आणि तो अंशतः मानसिक रूग्ण असल्याचा दावाही चेतनसिंह याने जामिना अर्जात केला आहे. या प्रकरणी आरोपपत्र दाखल झाले असून त्याला कोर्टात ठेवण्याची आवश्यकता नसल्याचा दावा करण्यात आला आहे.
