**1. INTRODUCTION:**

Mundra Thermal Power Station requires the services for the **period of three years** from competent parties having experience in Operation and Maintenance of Coal Handling Plant (CHP).

The tendering/ procurement activities for this Project are being managed from Tata Power’s following Office:

## 2. SCOPE OF WORK:

The brief scope of work shall comprise of round the clock operation & maintenance services for coal handling plant. The coal handling plant comprises of 2 sections – Internal Coal Handling and External Coal Handling. ICHS comprising of Conveyor belt system BCN-1, BCN-2A/B, Stacker cum Reclaimer(2Nos), Reclaimer(2Nos), BCN-3A/B to BCN-5A/B, Tripper Trolleys(6Nos.) including all relevant auxiliaries pertaining to ICHS directly or indirectly connected to its operation like Dry Fog system, DSS, Bunker Ventilation System, water sprinkling system, Firefighting system, Coal Sampling System, ILMS, ICS, Pull cord switches, Belt sway Switches, material lifting and handling equipments, Dozer, Metal Detector, Bunker Sealing System, Chutes, etc., all JNT aux. and structure located at MTPS premises from JNT-6 to Bunker floor at MTPS.

ECHS comprising of Conveyor belt system BCN-21A/B/C, BCN-22A/B, Stacker Reclaimer (6800T/hr), BCN-23 to BCN-28, PCN 1, BCN 1A including all relevant auxiliaries pertaining to ECHS directly or indirectly connected to its' operation like Dry Fog system, water sprinkling system, Firefighting system, ILMS, ICS, Pull cord switches, Belt sway Switches, Belt rip detector, Coal Sampling System, material lifting and handling equipments, Dozers, etc., all JNT aux. and structure located at Adani West Port to JNT-6 ICHS interface point near MTPS boundary.

Detailed Scope of Work for this Contract shall be provided in the Tender / RFQ document to all potential buyers submitting the valid EOI with due tender fees.

## 3. TENDER FEE & TIMELINES:

Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee (as indicated in Table 1) payment details to the contact details mentioned below not later than deadline specified below. Request for extension of EOI submission date will not be entertained and EOIs submitted beyond this deadline may be liable for rejection.

## 4. BIDDER PRE-QUALIFICATION REQUIREMENTS:

Bidder must fulfill the following bidder pre-qualification requirement / criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.



#### 4.1 TECHNICAL REQUIREMENT:

- a) Bidder should have minimum 5 years of experience in Operation & Maintenance of Coal Handling Plant of more than 1000MW at station level and above 500 MW at Unit level.
- b) Overall, the bidder should have handled Coal Handling plants having average capacity of at least 20,000 MT/Day, inclusive of Coal Feeding, Coal Transfer to main plant and unloading in preceding 3 yrs.
- c) Operating experience includes managing the entire operations from vessel unloading of coal to feeding at bunker having high speed belt conveyor, managing coal handling plant control room, Stacker/Reclaimer operations above 3000 TPH, coal stockpile management above monthly average stock of 5 Lacs MT, managing Permit to work systems, defect management, Lubrication etc.
- d) Maintenance experience includes electrical, mechanical and control & instrumentation works of equipment/systems/sub systems of coal handling plant with steel cord belt O&M

The agency shall submit documentary evidence in support of these qualifying criteria.

#### 4.2 FINANCIAL REQUIREMENT:

Bidder must have an Average Annual Turn Over of not less than Rs. 26 Crores during the last three financial years.

#### 4.3 SAFETY REQUIREMENT:

Bidder should preferably have ISO 9001 / ISO 14001 / ISO 45001 certification or must give an undertaking for its willingness to obtain the same within 2 months of qualification for the work.

#### 4.4 SUPPORTING DOCUMENTS (to be submitted with Technical Bid):

- a) Valid ISO Certificates True Copy
- b) PO Copy, Completion Certificate from the concerned client in support of successful execution of jobs /reference projects to be submitted.

d) Audited Balance Sheet and Profit & Loss Statement for last three completed financial years reckoned from the date of application. For FY24, in case the audited documents are not ready / available, then certified copy by a registered practicing Chartered Accountant may be submitted.

#### 5. BID SECURITY / EMD (to be submitted along with RFQ and not with EOI)

Interested parties to note that Bidder is required to furnish a Bid Security along with their Bid (only during Bid Submission stage), as a Bank Guarantee (in the format prescribed in Bid Document) or as NEFT/RTGS/DD for an amount of INR 8,50,000/- (INR Eight Lakhs Fifty thousand only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

#### 6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties that submitted a valid EOI as per terms mentioned in this document.

Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
