1. INTRODUCTION:

Tata Power Company limited is hereby inviting Expression of Interest (EOI) from interested and eligible parties for "Jjobbera Power Plant Ash Transportation And Stowing At Low Lying Sites ".

Jjobbera Thermal Power Station is owned by The Tata Power Company Ltd. Jjobbera Power Plant is having 1 no. x 67.5 MW and 4 nos. x 120 MW coal-based generation Units located in Jamshedpur in the State of Jharkhand in India.

Bids are invited for entering into **Rate Contract for Pond Ash Evacuation, Transportation and Stowing at Low Lying Sites for Jjobbera Power Plant via Road mode (Outline Agreement)** for a period of 1 Year.

Interested parties fulfilling the qualification criteria will be required to submit their bids (upload in Ariba online platform) as per the Instructions to Bid.

2. SCOPE OF WORK:

The details of the estimated ash quantity available under proposed contract period from Jjobbera Power Plant shall be as under:

The Tata Power's Jjobbera Power Plant (JPP) produces Ash on a regular basis through its coal-based power plant located at Jjobbera in Jamshedpur town of Jharkhand state. A part of the ash is pumped in slurry form to Ash Ponds located at Jemco Ash Ponds (behind Jemco and adjacent to M/s. Synpack) outside the plant premises. Regular evacuation of Ash is required to ensure buffer space in the Ponds.

Proposed Contract shall cover the scope for Transportation of Pond Ash from Jemco Ash Pond # 1 & 2 including its Evacuation/Excavation and stowing at suitable/approved Low Lying Land filling Sites. Proper Soil covering of sites post ash stowing shall be also included in scope as detailed below in Scope of work. Regular evacuation of Ash is required to ensure buffer space in the Ponds. ThFe work of evacuation and stowing shall be carried out on 24 x 7 basis OR as advised by Order Manager.

Local liaising will be contractor's scope. Compliance of environmental norms is also in contractor's scope. Detailed scope of work to be shared during RFQ stage.

Bidder may note that Owner reserves the right to revise tender quantity (increase/decrease) at any stage of tender and/or to split the quantity among multiple parties at its sole discretion.

Detailed Scope of Work for this Contract shall be provided in the Tender/RFQ document to all bidders submitting the valid EOI with due tender fees.

3. TENDER FEE & EOI SUBMISSION GUIDELINES AND TIMELINES:

a) Interested parties meeting the "Bidder pre-qualification criteria" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for Bid Document/EOI will not be entertained beyond this deadline.

e) Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

4. BIDDER PRE-QUALIFICATION REQUIREMENTS (PQR):

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ.

4.1 TECHNICAL REQUIREMENT:

a) Bidder should have experience of executing similar nature of contract of at least **2.0 LMT** ash through Road Mode i.e. via hyvas/trucks etc during **last Three Financial years (FY24,FY23 & FY22)**.

4.2 FINANCIAL REQUIREMENT:

a) Bidder shall have Average Annual Turn Over of not less than **INR 2 Crores** during the **last three financial years (FY24,FY23 & FY22)**.

b) Bidder will be required to submit copies of their profit and loss account and audited Balance sheet for the **last three preceding financial years**. In cases, where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.

4.3 NOTES FOR TECHNICAL AND FINANCIAL REQUIREMENTS:

- Tata Power reserve the right to disqualify any of bidder based on due diligence
- The BA's of existing similar contract @ Jojobera shall be deemed qualified (Financially & Technically both) for this tendering process, subject to the performance in existing contract
- JV/proprietorship/LLP/ any firm formed after 1st Jan'2021 shall not be considered eligible to participate in this tender
- Bidding entity shall meet the pre- qualification criteria on standalone basis including wholly owned subsidiaries if any.

- Subsidiary companies can bid provided they meet the qualification on standalone basis without relying on the credentials of the parent company. In case the parent company credentials are required to meet the qualification requirement, bidder must bid under the aegis of parent company only.

Net Worth means the sum total of the paid-up share capital and free reserves for private / public limited companies and the Surplus Capital employed by owners in a proprietorship / partnership company. Free reserves mean all reserves credited out of the profits and share premium account but do not include reserves credited out of the revaluation of assets, write back of depreciation provisions and amalgamation. Further, any debit balance of profit and loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from Reserves & Surplus. Other income shall not be considered for arriving at annual turnover.

5. BID SECURITY/EMD AT STAGE OF RFQ/BIDDING:

Interested parties to note that Bid Security is not required with the EOI and Bid Security will be required to be submitted only along with the Bid process (to happen subsequent to EOI and issue of Bid Document to valid EOI participants), via online transfer only for an amount of INR 10,00,000/- (Indian Rupees Ten Lakhs Only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive.

Interested parties to note that EMD/Bid Security is not required with the EOI and it is required to be submitted with the Bid during RFQ/Bidding stage, once RFQ is released to the interested parties submitting valid Expression of Interest.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (SAP Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this Tender Notice.

Bidder to note that bidding for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed during RFQ/Bidding Stage.
