1. TP Ajmer Distribution Limited intends to enter into a “Rate Contract (RC) for 3 years with suitable bidders for providing Metering and Testing Services at TPADL”.

TPADL intends to enter into a " **Rate Contract (RC) for 3 years with suitable bidders for providing Metering and Testing Services at TPADL.**

The scope of this proposal covers:

- i. All type of meters (including Solar meters) installation, dismantling, replacement & shifting jobs with cable / without cable, Meter Seal installation & replacement, Service cable replacement / installation's as per site requirement.
- ii. All type of civil activities those are associated with above services.
- iii. All type of meters (including Solar meters) & CT/PT testing at Parbatpura Testing Lab, Madar AVVNL Testing Lab, on site, Data Downloading of all type of meters, Modem - installation, dismantling, replacement works,
- iv. All works to be executed as per SLA.
- v. Providing sufficient quantity of competent Manpower (Supervisor/Lineman/Project coordinators/Helpers/Drivers/Safety cum Quality engineer), Vehicles, Safety tools & tackles, PPE to handle all type of above works as per requirement at site.
- vi. Meter Replacement works Without cable execution using 2-Wheeler.

3. It may be noted that all future correspondence and further communication shall be carried out strictly with those Interested Vendors who have completed the above-mentioned requirements, as specified in Section “B”, within the stipulated timeline.
4. Interested vendor after receiving the bid documents may clarify their queries during pre-bid meeting then only submit their quote in two parts as indicated below. The tenders submitted by vendors who do not participate in pre-bid meeting shall be deemed for rejection for further evaluation.

5. Stage for Bidder Qualification:

Stage 01- Safety Bid Evaluation – If passed then entertained for next stage.

Stage 02- Technical Evaluation - If passed then entertained for next stage.

Stage 03- Commercial Evaluation - If passed then entertained for further tender process.

6. Electrical Contractor License – Mandatory Requirement

A valid Electrical Contractor License issued by the Government of Rajasthan is mandatory for execution of electrical works under this contract.

Bidders who do not possess a valid Electrical Contractor License issued by the Government of Rajasthan at the time of submission of the bid may participate in the tender, provided that they submit an **Undertaking** on their letterhead stating that they shall obtain and submit the required license within **30 (Thirty) days** from the date of issue of the Letter of Award (LOA)/Work Order.

Failure to submit a valid Electrical Contractor License within the stipulated period of **30 (Thirty) days** from the date of notification shall attract a penalty equivalent to 10% (Ten Percent) of the Earnest Money Deposit (EMD) submitted by the Contractor. Such penalty shall be applicable for a further grace period of **30 (Thirty) days** and shall be recovered from the EMD, Security Deposit (SD), or any other amount payable to the Contractor.

In the event that the Contractor fails to submit the valid Electrical Contractor License even after the expiry of the aforesaid grace period, it shall be deemed that the Bidder is no longer interested in participating in the tender. Accordingly, the Bidder's **EMD shall be forfeited/blocked**, and the Purchaser reserves the right to take further action as per the tender conditions.
