The Tata Power Company limited is hereby inviting Expression of Interest (EOI) from interested and eligible parties for "Supply and Supervision services of installation, testing and commissioning of 132KV GIS and associated system for 3 x 67.5 MW co-generation power plant at TSL Neelachal Project" Kalinganagar Industrial Complex, near Duburi village, Jajpur district, Odisha, India.

2.1. General Scope:

Design, engineering, preparation of drawings, manufacture, assembly, testing, packing, dispatch and supply on door delivery basis to TSL-NINL of 132 KV GIS and associated system, supervision of installation, testing, commissioning to complete the work in all respects. Complete GIS comprising EHV components viz. circuit breaker, CT, PT, disconnecter switch, earthing switch, LA etc. shall be supplied based on valid type tested design of unit/factory, which supplied the GIS on which type test was carried out successfully. Detailed Scope of Work:

The detailed Scope of Work, Owner's Requirements, Limits of Supply, Exclusions, Technical Specifications, Performance Guarantees and Acceptance Criteria shall be as defined in Volume-II: Technical Specification, which shall form an integral part of this Contract.

3.4. Expression of Interest letter to be submitted along with tender fee payment details should include the following details:

- A covering letter duly stamped and signed by an authorized signatory clearly indicating the Tender Reference number and your EOI to participate in the tendering process.
- Tender fee payment details / reference no (ensure that tender fee is received by us within specified deadline)
- Bidder to indicate authorized person name, contact number and e-mail id (mandatory) of the person to whom RFQ / tender and all other communications to be addressed for this tender.

3.5. Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

4. BIDDER PRE-QUALIFICATION REQUIREMENTS:

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification requirement / criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.

4.1 TECHNICAL REQUIREMENT:

Bidder should have experience in Basic and Detailed Engineering, Procurement, Construction, Pre-commissioning, and Commissioning of the treatment for the following plants in India:

4.1.1 Bidder must be an OEM of EHV GIS with manufacturing facility/assembly in India.

4.1.2 Bidder shall have supplied 20 Nos of GIS bays (double busbar scheme) of 132kV in last 10 years as on the scheduled date of bid opening. Out of this, 10 nos of GIS bays must be in satisfactory commercial operation for atleast last 3 years as on the scheduled date of bid opening.

Indian subsidiaries of global companies having plant in India are also eligible to bid if the qualification requirements stated above are met independently or in combination with the parent company, Declaration from parent company needs to be submitted.

4.1.3 Bidder shall offer 132 kV GIS which is successfully type tested (as per IEC standard). Type test reports of offered 132 kV GIS design, manufactured either in Indian facility or in parent facility are acceptable.

The type test certificate of the 132 kV GIS shall not be more than 5 years old as on the scheduled date of bid opening. Time period for type test may be extended by another 5 years as a special case, if there is no change in design/material of construction (MOC).

4.2 FINANCIAL REQUIREMENT:

Bidder shall have an Average Annual Turn Over of not less than INR **100 Crores** during the last three financial years.

4.3 SUPPORTING DOCUMENTS (to be submitted with Technical Bid):

- A) Self-Undertaking (for EHV GIS manufacturing and testing facilities in India) to be submitted. Tata Power reserves the right to inspect the said manufacturing facility as a proof of compliance to this parameter.
- B) Supply list and performance certificates from the utilities/clients. Self-Undertaking (to confirm Indian subsidiaries of global companies having plant in India) to be submitted.
- C) Type test report.

Undertaking that there is no change in design/material of construction (MOC) if Type Test Report older than 5 years but less than 10years prior to date of bid opening has to be considered.

Undertaking that type test shall be carried out for the offered equipment /material from NABL/ International Accredited Lab without any cost implication to the owner and the Type Test reports shall be submitted before despatch of the equipment / material, in case type test reports furnished are not for the quoted equipment / material but for the equipment / material with higher voltage class and/or different capacity, (if applicable).

5. BID SECURITY / EMD:

Interested parties to note that Bidder will be required to furnish a Bid Security **along with their Bid**, in the format prescribed in Bid Document **in the form of Bank Guarantee/ DD/ RTGS**, for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Interested parties to note that Bid Security is not required with the EOI and it is required to be submitted with the Bid only during Bid Submission stage, once RFQ is released to the interested parties that have submitted a valid EOI.
