Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ

4.1 TECHNICAL REQUIREMENTS:

Eligibility Criteria for the ASH handling system- Dry ash line replacement

A. Experience

- Vendor should Minimum 5 Years experience for pipe (MS &CB) replacement at pipe rack.
- Vendor should have completed at least 3 successful Pipe replacement at pipe rack at Hight (EL- Approx 12- 18 Mtr) in Ash Handling in the last 5 years.
- Experience in Pipe replacement at pipe rack in Ash Handling is mandatory.
- Work orders and completion certificates to be submitted as proof.

B. Technical Capability

- Experience must include the following components:
 - Dismantling and Erection of Pipe replacement at pipe rack in Ash Handling system.

C. Manpower

- Vendor shall deploy skilled manpower having experience in ash handling systems, especially in pipe replacement and Manpower strength and deployment chart must be submitted.

D. Statutory Requirements

- GST registration certificate
- ESI, PF registration
- Labour license for similar work in UP govt.
- Safety and quality certifications

E. Past Performance Evaluation

- Feedback from previous company Pipe replacement jobs.
- Credentials required for the last-3 years Pipe replacement jobs awarded PO copies.

- Any blacklisting or contract termination history must be disclosed

F. Safety & Quality Assurance

- Vendor must follow site safety guidelines strictly
- Safety officer must be deployed during Pipe replacement jobs

4.2 Expression of Interest Submission:

Interested vendors are invited to submit an Expression of Interest (Eoi) along with a detailed company profile.

The profile should clearly demonstrate:

Technical capabilities,

Relevant project experience and credentials,

Association or tie-up with OEM/OES (if applicable),

Track record in providing similar services for 660 MW and above boiler units.

5. BID SECURITY:

Interested parties to note that Bidder is required to furnish a Bid Security along with their Bid during bidding stage once the RFQ/tender document is issued to bidder/s submitting valid EOI. Bid security may be submitted in Bid Document for an amount as defined in the covering page of this notice document (Table-1). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Note: Interested parties to note that Bid Security is not required with the EOI and it is required to be submitted with the Bid during Bid Submission stage, once RFQ is released to the interested parties submitting valid Expression of Interest.

6. BIDDING PROCESS:

Detailed Bid Document (also referred to as RFQ) shall be issued through PPGCL e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

Bidders note that bidding for Boiler Overhauling Services for Rotary Prats, ESP & Duct Damper Unit #3 as per above tender shall be conducted based on the actual services quantity of the service quoted by bidder/s. Quantity Requirement/ Minimum Quantity Commitment indicated by bidders shall also be taken into consideration. The owner shall reserve the right to decide the bid evaluation criteria for deciding the optimum price of Boiler Overhauling Services for Rotary Prats, ESP & Duct Damper Unit #3. Bidder to note that bidding for subject tender may be conducted through e-auction.
