1. INTRODUCTION:

Ministry of Power (Mop) issued revised policy dated 8th Oct 2021 with notification number 11/86/2017-Th. II, for Power generation through Co-firing of Biomass in Coal Based Power Plants. Tata Power Company limited is hereby inviting Expression of Interest (EOI) from interested and eligible parties for "**SUPPLY OF BIOMASS PELLETS TO TATA POWER, JOJOBERA THERMAL POWER STATION**"

Jojobera Thermal Power Station is **domestic** coal based thermal power generation plant with 5 units of total capacity 547.5 MW, located at village **Rahargorah, Jojobera, Jamshedpur, East Singhbhum, Jharkhand - India.**

The tendering/procurement activities for this Project are being managed from Tata Power's following Office:

2. SCOPE OF WORK:

The details of the estimated Biomass quantity required under proposed contract period is as under:

The brief Scope of Work under this tender shall be to deliver of biomass at the designated delivery point at **Jojobera** Thermal Power Station in line with detailed scope of work/ T&C/Technical specification **via road mode logistics**. The supplier shall deliver the ordered quantity **after issue of purchase order, barring monsoon period of 4 Months (Monsoon Period of 4 months shall be June 25 to Sept 25)**. Price shall be **valid for the period of 1 year from the date of issuance of order.**

The scope of bidder/ Supplier shall include- Supply of biomass in preferably in self-tipping truck including unloading, entire logistics arrangement, transportation, and other associated work for the contracted quantity of biomass on consistent and continuous basis over the stipulated contract period.

Bidders to note that above is generic description of Scope of work and Detailed Scope of Work/ Technical Specifications, Terms & Conditions including quantities/ tenure for subject Tender shall be specified & finalized during the Tender RFQ (Request for Quotation) stage, which shall be issued to interested parties submitting valid EOI and Tender Fee as prescribed in this Tender Notice.

3. TENDER FEE & EOI SUBMISSION GUIDELINES AND TIMELINES:

a) Interested parties meeting the "Bidder pre-qualification criteria" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. Request for Bid Document/EOI will not be entertained beyond this deadline.

4. BIDDER PRE-QUALIFICATION CRITERIA:

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification criteria in order to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ.

4.1 TECHNICAL REQUIREMENT:

a) Bidder should have Minimum supply/Production capacity of 100 TPD.

b) Bidder should have executed at-least one contract including scope of supply including transportation / logistics responsibility. New supplier having no past experience of logistics may submit supporting credential of logistics capability through their own / tie-up's.

4.2 FINANCIAL REQUIREMENT:

a) Bidder should have annual average turnover of last three financial years an Average Annual Turn Over of not less than INR 5 Crores.

4.3 NOTES FOR TECHNICAL AND FINANCIAL REQUIREMENTS:

Bidder will be required to submit copies of their profit and loss account and audited Balance sheet for the last three preceding financial years along with the Bid Document. In cases, where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.

5. BID SECURITY/EMD:

Interested parties to note that Bid Security is not required with the EOI and Bid Security will be required to be submitted only along with the Bid process (to happen subsequent to EOI and issue of Bid Document to valid EOI participants), via online transfer only for an amount of INR 2,00,000/- (Indian Rupees Two Lakhs Only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive.

Interested parties to note that EMD/Bid Security is not required with the EOI and it is required to be submitted with the Bid during RFQ/Bidding stage, once RFQ is released to the interested parties submitting valid Expression of Interest.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (SAP Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this Tender Notice.

Bidder to note that bidding for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed during RFQ/Bidding Stage.

Pls note that, Bidders are currently required to submit EOI and relevant documents through Email addresses mentioned above only. No need to send physical mail/courier.
