	Leasing of available OPGW/Dark Fiber in Mumbai Transmission Network	

TATA Power has OPGW /underground fiber cable laid on Transmission network which is spread across the city of Mumbai and up to Hydro-Electric Power Stations. These Hydro plants are connected to Mumbai Transmission network through either 220 kV or 110 kV lines. Tata Power's Thermal Power Plant is located at Trombay and is connected to Mumbai Transmission network through either 220 kV or 110 kV lines. Tata Power Transmission network have multiple Receiving Stations (RSS) located in various areas of Mumbai. These RSS are networked through either 220 kV or 110 kV lines.

Currently, there is a spare optical fiber network (3048 Fiber pair KM) available and TATA Power Mumbai Transmission is planning effective utilization of Transmission network by leasing this spare optical fiber.

Pre-requisite conditions:

- 1) Tata Power intends to lease available/under construction OFC network to single operator/multiple parties on single cable considering available capacity on any route.
- 2) Interested parties should be in possession of valid licenses and should furnish the copies of the same with their expression of interest offer.
- 3) Tata Power reserves the right to split the entire fiber network into full/ lots and sign agreement with multiple parties. The formation of lots if any shall be the sole responsibility of Tata Power.
- 4) Selected Partner is supposed to use Dark Fiber for their own use only and are not supposed to Sub-lease further. In case sub-leasing is necessary then Selected Partner must submit their requirement in writing to Tata Power. Tata Power reserves the right to allow / not allow sub-leasing. It will be at sole discretion of Tata Power and no explanation whatsoever shall be given if sub-leasing is not allowed. Also Selected Partner will be needed to disclose all relevant information as sought by Tata Power for such sub-leasing requirement.
- 5) Decision on lease of part or complete inventory will rest completely with Tata Power.
- 6) Tata Power will provide Fiber availability as 99% on best effort basis.
- 7) In addition to above, Bidder having O&M experience of OPGW network on Power Transmission Lines/ overhead fiber network for a minimum of five hundred (500) Km for minimum 3 years shall be preferred.
