1. INTRODUCTION:

Prayagraj Power Generation Company Limited (PPGCL) owns and operates 3x660 MW capacity Indian coal based thermal power generation station based on pulverized coal-based super-critical boiler technology. PPGCL requires the services of competent parties having experience in bulk material transportation through road (Ash transportation experience is preferable) for ash transportation from Ash Ponds of 3 x 660 MW, Super Critical Power Plant at Bara, U.P. for back filling to nearby low-lying / abandoned mine areas

2. SCOPE OF WORK:

Work to be carried out but not limited to:

- ✓ The scope of work shall comprise of Transportation and disposal of pond ash outside the PPGCL plant premises to nearby low-lying / abandoned mines with requisite vehicles, loaders, excavators, tools & tackles, consumables, and required Supporting staff Detailed Scope of Work for this Contract shall be provided in the Tender / RFQ document to all potential buyers submitting the valid EOI with due tender fees.

3. TENDER FEE & TIMELINES:

- a) Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee (as indicated in Table 1) payment details to the contact details mentioned below not later than deadline specified below. Request for extension of EOI submission date will not be entertained and EOIs submitted beyond this deadline may be liable for rejection.

4. BIDDER PRE-QUALIFICATION REQUIREMENTS:

Bidder must fulfill the following bidder pre-qualification requirement / criteria to qualify for the subject work. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document / RFQ and bidders not found meeting the pre-qualification requirements given below will be disqualified from the tender.

4.1 TECHNICAL REQUIREMENT:

1. The Bidder must have executed work order(s) for the transportation of ash or bulk material totalling at least **50,000 metric tonnes (MT) or cubic meters (Cum)** within the **last three (3) years**, either through a single contract or cumulatively across multiple work orders.
2. The Bidder must possess access to a **low-lying area or abandoned mine** with a **minimum ash stowing capacity of 1,00,000 MT**, located within a **maximum distance of 16 kilo meters** from the **PPGCL Plant**.
3. The land intended for ash stowing must either be **owned directly by the Bidder** or the Bidder must hold a valid **No Objection Certificate (NOC)** from the landowner. The NOC must be duly **verified by the competent authority of Uttar Pradesh**.
4. Bidders who have **successfully completed ash transportation work at PPGCL within the last three (3) years** may be deemed technically qualified under this tender. The **decision of the PPGCL authority** in this regard shall be **final and binding** on all bidders.

4.2 FINANCIAL REQUIREMENT:

- Bidder should be an independent company, a proprietorship firm, a partnership firm or a combination of the above in form of Joint venture Company, registered as per Companies Act. Bidder to share relevant details of the bidding entity.
- Bidder should share Certified copy of Income TAX, PAN, GST/ Other Taxes Duties Certificate and EPF registration (or undertaking in case not applicable) issued by competent authority.

4.3 SUPPORTING DOCUMENTS (to be submitted with Technical Bid):

- a) PO Copy, Work Completion Certificate or certified Invoice Copy from the concerned client in support of successful execution of jobs /reference projects to be submitted.
- b) Experience details of past 03 years should be submitted in RFQ.

5. BID SECURITY / EMD (to be submitted along with RFQ and not with EOI)

Interested parties to note that Bidder will be required to furnish a Bid Security along with their Bid, in the format prescribed in Bid Document in the form of RTGS for an amount as defined in the covering page of this notice document. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Interested parties to note that Bid Security is not required with the EOI, and it is required to be submitted with the Bid only during Bid Submission stage once RFQ is released to the interested parties that have submitted a valid EOI.

6. BIDDING PROCESS:

Detailed Bid Document (also referred to as RFQ) shall be issued through PPGCL e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document. Bidder to note that commercials for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed in the RFQ / tender document.
