1. INTRODUCTION:

Maithon Power Limited (MPL) is a 74:26 joint venture of TATA Power Company Limited and DVC (Damodar Valley Corporation). MPL operates 2x525 MW capacity, Indian coal based thermal power generation plant located in Maithon near the city of Dhanbad in the state of Jharkhand in India. MPL requires ~4.5 million metric tonnes (MMT) of coal annually for its 2x525 MW Thermal Power Station at Maithon, Dhanbad district, Jharkhand (hereinafter referred as "Plant"). This coal is being presently sourced from BCCL/CCL/Any other subsidiary of CIL and transported through Rail / Road & Rail-cum-Road (R-C-R) mode of logistics.

In view of above, MPL plans to tie up new contract for the transportation of coal via Road Mode from various collieries/mines/sidings of CCL/BCCL/Any other subsidiary of CIL and/or other coal company upto Maithon Power Limited's Plant. Tata Power on behalf of MPL is conducting this tender and hereby inviting Expression of Interest (EOI) from reputed and experienced parties for the work of "**Transportation of Coal via Road Mode from ECL to Maithon Power Limited**".

The tendering/procurement activities for this Project are going to be driven from Tata Power's following Office:

Coal quantity proposed under this contract shall be quantity acquired by MPL under various FSAs/ E-auctions/ Import substitution etc. Applicable scope of work for this tender shall be as detailed under point no 2 of this Tender Notice. Proposed contract period for this contract shall be 1 year from the date of commencement of contract. Coal quantity expected to be covered under this contract shall be approximately **~3 Lakhs MT /Annum**. It may be noted that above is tentative estimated quantum of work and owner reserves right to vary (increase/decrease) quantity at any stage of tender/contract as per the Plant's operational requirements and other requirements.

2. SCOPE OF WORK:

Scope of work under this proposed contract shall include the following-

Scope of Work for this proposed contract shall include (but not limiting to) co-ordination with coal companies for allocation from desired mines of ECL, lifting of coal from mines, transportation upto Maithon Thermal Power Station through road mode, delivery & unloading at MPL designated unloading point at Site as per MPL prescribed guidelines. Contractor scope shall also include the activities to supervise and ensure that good quality coal is loaded at the mine end and other allied works as per detailed scope of works of this Tender. The contract shall be tied up tentatively for 1 years from the date of award (LOA/PO) for the above scope of work for estimated annual coal quantity to the tune of **3.00 Lakhs Metric Tonnes (MT)/ Annum**. Above work contract may be awarded on basis of various groups of Slabs of Lead distance (Chargeable distance) between Mine end to Plant end (estimated distance slabs shall be four). Indicative distance slab are as follows.

Exact details of the proposed Lead distance slabs and estimated tentative quantities of respective distance slabs shall be specified in detailed Tender RFQ (Request for Quotation) document at a later stage. Owner shall reserve the right to award entire contract quantity to single contractor or split the contract quantity among multiple contractors.

Bidders to note that above is generic description of Scope of work and Detailed Scope of Work/ Technical Specifications, Terms & Conditions including quantities/ tenure for subject Tender shall be specified & finalized during the Tender RFQ (Request for Quotation) stage, which shall be issued to interested parties submitting valid EOI and Tender Fee as prescribed in this Tender Notice.

3. TENDER FEE & TIMELINES:

a) Interested parties meeting the "Bidder Pre-Qualification Requirements" specified under point no. 4 in this document can request tender document and participate in the bidding process by submitting the Expression of Interest (EOI) Letter along with the Tender Fee Payment Details to the contact details mentioned below not later than deadline specified below. e) Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this document.

4. BIDDER PRE-QUALIFICATION REQUIREMENTS (PQR):

Interested parties to note that Bidder shall be required to fulfill the following bidder pre-qualification requirement/ criteria in order to qualify for the subject work tender. Bidder will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission stage against Tender document/RFQ and bidders not found meeting the pre -qualification requirements given below will be disqualified from the tender.

4.1 TECHNICAL REQUIREMENTS:

- a) The bidder must have experience of similar nature and must have executed minimum 1 contract of similar scope of work for Road / RCR Mode logistics during last 3 (Three) years (i.e., last 3 Financial Year FY22, FY23 & FY24) for Power Plant consumers only.
- b) Bidder must have experience of executing contract/s of similar scope of work involving Road/RCR mode logistics of handling minimum **1.5 Lakhs MT** from any or cumulative from following CIL subsidiaries : BCCL /CCL/ECL/NCL, during last 3 years (i.e., last 3 Financial Year FY22, FY23 & FY24) for Power Plant Consumers in a single or multiple orders.

Note

1. For technical evaluation bidder shall submit the relevant contract copy & associated performance certificate from client as necessary for substantiating above experience credentials.

2. In case performance certificate is not available, BA shall get the same confirmed from Client over email.

In case of JV

- a) The JV must be at least 8 years old on the day of EOI submission i.e. the JV should have been incorporated before Sep'18.
- b) The Bidding Entity (not the individual JV partners) must have requisite experience as mentioned in point 4.1 (a & b) above

4.2 FINANCIAL REQUIREMENTS:

Bidder shall have adequate financial resources to execute the Contract concurrently with his other commitments and shall meet the following conditions.

- a) Bidder shall have during the last three financial years an Annual Average Turn Over of not less than INR. 20 Crores.

Notes for Financial Requirements

1. Net Worth means the sum total of the paid-up share capital and free reserves for private / public limited companies and the Surplus Capital employed by owners in a proprietorship / partnership company. Free reserves mean all reserves credited out of the profits and share premium account but do not include reserves credited out of the revaluation of assets, write back of depreciation provisions and amalgamation. Further, any debit balance of profit and loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from Reserves & Surplus. Other income shall not be considered for arriving at annual turnover.
2. Bidder will be required to submit copies of their profit and loss account and audited Balance sheet for the last three preceding financial years along with the Bid Document. In cases, where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.

Note:

- **Existing vendors executing contract/s of similar scope of work involving Road mode coal logistics at Maithon Power Limited from BCCL /CCL shall be considered eligible (technically & financially) for participation.**
- **As per operational requirement of the plant any of the vendor who is already in an agreement with Maithon Power Limited for coal Transportation under Rail or RCR mode shall not be eligible for the subjected tender.**
- **Bidder with price bid lower than the estimated price bid (internally calculated by MPL/Tata Power) may not be considered for evaluation. Estimated/Internal price bid value shall not be disclosed.**
- **MPL / Tata Power reserve the right to disqualify any of bidder based on due diligence.**

5. BID SECURITY/EMD AT STAGE OF RFQ/BIDDING:

Interested parties to note that Bid Security is not required with the EOI and Bid Security will be required to be submitted only along with the Bid process (to happen subsequent to EOI and issue of Bid Document

to valid EOI participants), via online transfer only for an amount of INR 25,00,000/- (Indian Rupees Twenty Five Lakhs Only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive.

Interested parties to note that EMD/Bid Security is not required with the EOI and it is required to be submitted with the Bid during RFQ/Bidding stage, once RFQ is released to the interested parties submitting valid Expression of Interest.

6. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (SAP Ariba System) only to the parties submitting a valid EOI as per terms mentioned in this Tender Notice.

Bidder to note that bidding for subject tender may be conducted through e-auction. Detailed bidding and auction process shall be detailed during RFQ/Bidding Stage.
